**BAC RESOLUTION DECLARING MALONES PRINTING PRESS AND PUBLISHING HOUSE
AS THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING
THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE
PRINTING OF STUDENT CODE OF DISCIPLINE**

BAC RESOLUTION NO. 55, s. 2021

- WHEREAS,** the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Printing of Student Code of Discipline with an ABC of Php 520,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the University;
- WHEREAS,** in response to the said advertisement, three (3) prospective bidders submitted LOI and applied for eligibility and bought bid documents;
- WHEREAS,** during the Opening of Bids conducted on March 8, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the three (3) prospective bidders where result showed that Malones Printing Press and Publishing House and Makinaugalingon Printer and Bookbinder were found to be eligible and had complied with the bidding requirements, while Hometown Printing Press was found to be non-compliant to technical specifications as required by the end-user;
- WHEREAS,** opening of Bids conducted on March 8, 2021 had the following result:

WHEREAS, a bid evaluation, verification and post-qualification was conducted by the members of the BAC and TWG on the eligibility and technical requirements submitted by **Malones Printing Press and Publishing House** where result showed that it was found to be responsive;

NOW THEREFORE, we, the members of the Bids and Awards Committee **RESOLVE**, as it is hereby **RESOLVED**:

- to declare **Malones Printing Press and Publishing** as the Lowest Calculated Responsive Bid (LCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Printing of Student Code of Discipline;
- that the said contractor had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.


- c. that the University President shall recommend to the Board of Regents the approval of the Awarding of Contract and Notice to Proceed with the Printing of Student Code of Discipline;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.


