**BAC RESOLUTION DECLARING [REDACTED] AND PHILIPPINE
DUPLICATORS, INC. AS THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND
RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED
WITH THE PROCUREMENT OF ICT EQUIPMENT AND
PHOTOCOPIER MACHINE, FUND -101**

BAC RESOLUTION NO. 17, s. 2021

WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Procurement of ICT Equipment and Photocopier Machine, F-101 with an ABC of PhP 570,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the University;

WHEREAS, in response to the said advertisement, two (2) prospective bidders submitted LOI and applied for eligibility and bought bid documents;

WHEREAS, basis of awarding should be through line item;

WHEREAS, during the Opening of Bids conducted on March 8, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the two (2) prospective bidders where result showed that both were found to be eligible and had complied with the bidding requirements;

WHEREAS, line item awarding had this result:

NOW THEREFORE, we, the members of the Bids and Awards Committee **RESOLVE**, as it is hereby **RESOLVED**:

- to declare **Computron Business Center and Philippine Duplicators, Inc.** as the Lowest Calculated Responsive Bid (LCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Procurement of ICT Equipment and Photocopier Machine, F-101;
- that the said contractor had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.
- that the Bids and Awards Committee (BAC) shall recommend to the University President the approval of the Awarding of Contract and Notice to Proceed with the Procurement of ICT Equipment and Photocopier Machine, F-101;


- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
