BAC RESOLUTION DECLARING RCORDS INDUSTRIAL SUPPLIES AND SERVICES
AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING
THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE
PROCUREMENT OF SERVICES FOR THE QUARTERLY
PREVENTIVE MAINTENANCE OF FIRE PROTECTION SYSTEM

## BAC RESOLUTION NO. 22, s. 2021

WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for

Eligibility and to Bid with the Procurement of Services for the Quarterly Preventive Maintenance of Fire Protection System with an ABC of PhP 512,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in

the premises of the University;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder submitted

LOI and applied for eligibility and bought bid documents;

WHEREAS, during the Opening of Bids conducted on March 30, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder where result showed that

was found to be eligible and had complied with the bidding requirements;

WHEREAS, opening of bids conducted on March 30, 2021 had this result:

WHEREAS, a bid evaluation, verification and post-qualification was conducted by the members of the BAC and TWG on the eligibility and technical requirements submitted by *RCORDS Industrial Supplies and Services* where result showed that it was found to be responsive;

WHEREAS, RCORDS Industrial Supplies and Services having been declared as the Single Calculated Responsive Bid (SCRB), showed that the bid amount as calculated is lower than the bid as read, therefore the award of contract to the said bidder shall be at its submitted price or its calculated price; whichever is lower, as provided under Sec. 34.4 of the 2016 Revised IRR of RA 9184. The Bid as Calculated amounting to PhP 474,357.54 shall be awarded to the bidder;

NOW THEREFORE, we, the members of the Bids and Awards Committee RESOLVE, as it is hereby RESOLVED:

a. to declare RCORDS Industrial Supplies and Services as the Single Calculated Responsive Bid (SCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Procurement of Services for the Quarterly Preventive Maintenance of Fire Protection System;

- b. that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.
- c. that the Bids and Awards Committee (BAC) shall recommend to the University President the approval of the Awarding of Contract and Notice to Proceed with the Procurement of of Services for the Quarterly Preventive Maintenance of Fire Protection System;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
