WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Procurement of Equipment for the Upgrading of Environmental Research and Analytical Laboratory under Research and Development Hub of ISAT I with an ARC of PhD 3 244 245 00 in the Publication

Development Hub of ISAT U with an ABC of PhP 3,241,345.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the

University;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder submitted

LOI and applied for eligibility and bought bid documents;

WHEREAS, basis of awarding is on a lot basis;

WHEREAS, during the Opening of Bids conducted on February 22, 2021, proper scrutiny

and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder where result showed that it was found

to be eligible and had complied with the bidding requirements;

- a. to declare Gryke Scientific Instruments Trading as the Single Calculated Responsive Bid (SCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Procurement of Equipment for the Upgrading of Environmental Research and Analytical Laboratory under Research and Development Hub of ISAT U;
- b. that the said contractor had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.

- c. that the University President shall recommend to the Board of Regents the approval of the Awarding of Contract and Notice to Proceed with the Procurement of Equipment for the Upgrading of Environmental Research and Analytical Laboratory under Research and Development Hub of ISAT U;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
