BAC RESOLUTION DECLARING S.M. BALOYO DENTAL LABORATORY, SUPPLIES AND EQUIPMENT AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE PROCUREMENT OF DENTAL EQUIPMENT, F-164

BAC RESOLUTION NO. 30, s. 2021

WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Procurement of Dental Equipment, F-164 with an ABC of PHP 430,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the University;

WHEREAS, in response to the said advertisement, two (2) prospective bidders applied for eligibility and bought bid documents;

WHEREAS, basis of awarding should be on a one lot basis;

WHEREAS, during the Opening of Bids conducted on May 26, 2021, only the S.M. Baloyo Dental Laboratory, Supplies and Equipment dropped its bidding documents while another bidder was on a no show;

WHEREAS, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder, where result showed that it was found to be eligible and had complied with the bidding requirements;

WHEREAS, opening of bids had this result:

WHEREAS, a bid evaluation, verification and post-qualification was conducted by the members of the BAC and TWG on the eligibility and technical requirements submitted by **S.M. Baloyo Dental Laboratory, Supplies and Equipment** where result showed that it was found to be responsive;

NOW THEREFORE, we, the members of the Bids and Awards Committee RESOLVE, as it is hereby RESOLVED:

- to declare **S.M. Baloyo Dental Laboratory, Supplies and Equipment** as the Single Calculated Responsive Bid (SCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Procurement of Dental Equipment;
- that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.


- c. that the Bids and Awards Committee (BAC) shall recommend to the University President the approval of the Awarding of Contract and Notice to Proceed with the Procurement Dental Equipment;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
