**BAC RESOLUTION DECLARING WINTERFIELD MARKETING AS THE
LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND ITS RECOMMENDATION FOR THE
AWARDING OF CONTRACT AND NOTICE TO PROCEED FOR THE
PROCUREMENT OF CONSTRUCTION MATERIALS AND SUPPLY**

BAC RESOLUTION NO. 14 s. 2021

- WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid for the **Procurement of Construction Materials and Supplies** with an ABC of PhP 3,883,375.00 in the PhilGEPS, ISAT-U Website and in the conspicuous place in the premises of the University;
- WHEREAS, in response to the said advertisement, **three (3) prospective bidders** expressed their intention to join the Competitive Bidding by submitting their bid documents;
- WHEREAS, during the Opening of Bids conducted on **March 8, 2021**, proper scrutiny and bid evaluation on the bid documents were conducted by the BAC and TWG. The table below shows the actual results:

- WHEREAS, **Winterfield Marketing** and **Conquest Construction Supply and Parts** were declared eligible and compliant;
- WHEREAS, **South Pacific Builders** was found to be non-compliant for failure to follow the guidelines on how to prepare the bidding documents as provided under **Section 17.2 of the 2016 Revised IRR od RA 9184**;
- WHEREAS, as per bid evaluation, verification and post-qualification conducted by the BAC and the TWG, **Winterfield Marketing** has the **Lowest Calculated and Responsive Bid**;
- WHEREAS, **Winterfield Marketing** having been declared as the **Lowest Calculated and Responsive Bid (LCRB)**, showed that the bid amount as calculated is higher than the bid as read, therefore the award of contract to the said bidder at its submitted price or its calculated price, whichever is lower, as provided under **Section 34.4 of the 2016 Revised IRR of RA 9184**. The **Bid as Read** amounting to PhP **3,622,084.25** shall be awarded to the bidder;

NOW THEREFORE, we the members of the Bids and Awards Committee **RESOLVE**, as it is hereby **RESOLVED**:

- to declare **Winterfield Marketing** as the **Lowest Calculated and Responsive Bid (LCRB)** and for complying the technical specifications set by the Technical Working Group (TWG) and End-User with the **Procurement of Construction Materials and Supplies**;
- that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.

- c. that the University President shall recommend to the Board of Regents the approval of the Awarding of Contract and Notice to Proceed with the Procurement of Construction Materials and Supplies;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.


