WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Procurement of Interactive Projector, F-101 with an ABC of PHP 320,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the University;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder applied for eligibility and bought bid documents;

WHEREAS, basis of awarding should be on a one lot basis;

WHEREAS, during the Opening of Bids conducted on August 31, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder, where result showed that it was found to be eligible and had complied with the bidding requirements;
