BAC RESOLUTION DECLARING GABIGROUP, INC. AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE PROCUREMENT OF FABRICATION LABORATORY EQUIPMENT (FABLAB) AND SOFTWARE (PROFESSIONAL SUPER SPEED ROUND CYLINDER UV PRINTER)

BAC RESOLUTION NO. 61, s. 2021

WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for

Eligibility and to Bid with the PROCUREMENT OF FABRICATION AND LABORATORY (FABLAB) EQUIPMENT AND SOFTWARE with an ABC of PhP 5,150,000.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous

place in the premises of the University;

WHEREAS, the Procurement of Fabrication and Laboratory (FABLAB) Equipment and

Software have the following items:

Item No. 1 - Professional Super Speed round Cylinder UV Printer

Item No. 2 - CNC Milling Machine with ATC

WHEREAS, in response to the said invitation two (2) prospective bidders applied for

eligibility and bought bid documents;

WHEREAS, procurement mechanism is by line item;

WHEREAS. during the Opening of Bids on November 22, 2021, GABIGROUP Inc. submitted

its bid documents for item no. 1 only which is the Professional Super Speed

Round Cylinder UV Printer;

WHEREAS, proper scrutiny and bid evaluation were conducted by the BAC and TWG

members on the bid documents submitted by GABIGROUP Inc., where result showed that it was found to be eligible and had complied with the bidding

requirements;

WHEREAS, opening of bids for item no. 1 (Professional Super Speed Round Cylinder UV

a. to declare GABIGROUP INC. as the Single Calculated Responsive Bid (SCRB) and for complying the technical specifications set by the Technical Working Group (TWG)

and End-user with the Procurement of Fabrication Laboratory (FABLAB) Equipment and Software (Professional Super Speed Round Cylinder UV Printer);

- b. that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.
- c. that the Bids and Awards Committee (BAC) shall recommend to the University President the approval of the Awarding of Contract and Notice to Proceed with the Procurement of Fabrication Laboratory (FABLAB) Equipment and Software (Professional Super Speed Round Cylinder UV Printer);
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
