BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF GENERAL SERVICES AND MAINTENANCE FUND 101 (EARLY PROCUREMENT) Project Reference No. ISAT U GOODS- 2022-01-01

RESOLUTION NO. 04, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of General Services and Maintenance Fund 101 (Early Procurement) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on 24 November 2021. The total Approved Budget for the Contract (ABC) of Two Million Nine Hundred Fifty Seven Thousand Four Hundred Forty Four Pesos (PhP 2,957,444.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 3 December 2021 and was attended by the following prospective bidders:

- 1. Pacific Sun Manpower Solutions
- 2. Tekton Entre-Workers Cooperative Iloilo

WHEREAS, in response to the said posting, two (2) prospective bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 17 December 2021, to wit:

- 1. Pacific Sun Manpower Solutions
- 2. Tekton Entre-Workers Cooperative Iloilo

WHEREAS, during the opening of bids held on 20 December 2021, the two (2) prospective bidders were declared "passed" during the preliminary examination of bids.

WHEREAS, during Bid Evaluation, the BAC had the following findings:

WHEREAS, Tekton Entre-Workers Cooperative Iloilo is a cooperative where under the Section 4-116 of RA 10963 with amendments made by BIR RR No. 13-2018 from RR 16-2005 on the implementation of VAT, is found to be VAT Exempt;

WHEREAS, as per GPPB Circular No. 02-2010 (3.3), the computation of Bid as Read and as Calculated with VAT inclusion is for the purpose to ensure that all bids shall be evaluated on equal footing, all taxes itemized by non-cooperatives in their bid and which cooperatives are tax exempt shall be added to the bid of cooperatives strictly for purposes of evaluation and comparison;

WHEREAS, under Section 34.4 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 or otherwise known as the "Philippine Government Procurement Act", it expressly provides that:

If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB66, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.

WHEREAS, the Technical Working Group (TWG) is hereby recommending to award the contract to Pacific Sun Manpower Solutions at its Bid Amount as Calculated which is lower than the Bid Amount as Read based on the actual results as follow:
