**BAC RESOLUTION DECLARING BACOLOD ELKAN TRADING, INC. AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE PROCUREMENT OF SPORTS EQUIPMENT, F-101**

**BAC RESOLUTION NO. 59, s. 2021**

**WHEREAS,** the Iloilo Science and Technology University advertised the Invitation to Apply for Eligibility and to Bid with the Procurement of Sports Equipment, F-101 with an ABC of PhP 153,500.00 in the Phil-GEPS, ISAT-U Website and in the conspicuous place in the premises of the University;

**WHEREAS,** in response to the said advertisement, only one (1) prospective bidder applied for eligibility and bought bid documents;

**WHEREAS,** procurement mechanism in on a one lot basis;

**WHEREAS,** during the Opening of Bids on October 12, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder, where result showed that it was found to be eligible and had complied with the bidding requirements;

**WHEREAS,** opening of bids had this result:

- that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.
