BAC RESOLUTION DECLARING CLIPDATA COMPUTER CENTER AS THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE PROCUREMENT OF NETWORKING WIFI SYSTEM, F-164

BAC RESOLUTION NO. 56, 2021

WHEREAS, the Iloilo Science and Technology University advertised the Invitation to Apply for

Eligibility and to Bid with the Procurement of Networking Wifi System, F-164 with an ABC of PhP 450,000.00 in the Phil-GEPS, ISAT-U Website and in the

conspicuous place in the premises of the University;

WHEREAS. in response to the said advertisement, three (3) prospective bidders applied for

eligibility and bought bid documents;

WHEREAS, basis of awarding should be on a one lot basis;

WHEREAS, during the Opening of Bids on October 12, 2021, proper scrutiny and bid

evaluation were conducted by the BAC and TWG members on the bid documents submitted by the three (3) prospective bidders, where result showed that all were found to be eligible and had complied with the bidding

requirements;

d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
