WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for PROCUREMENT OF ATHLETIC SUPPLIES FOR P.E. DEPT. on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on 24 March 2022. WHEREAS, in response to the said posting, only Bacolod Elkan Trading, Inc. purchased the bidding documents and submitted its bid offer on the deadline, 18 April 2022 at 5pm;

WHEREAS, the Opening of Bids was conducted on 19 April 2022;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, the BAC had the following findings:
