**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
AND RECOMMENDING AWARD FOR THE PROCUREMENT OF OFFICE SUPPLIES**

RESOLUTION NO. 330 s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF OFFICE SUPPLIES** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **24 March 2022**. The total Approved Budget for the Contract (ABC) of **Three Hundred Seventy Eight Thousand Three Hundred Ten Pesos (Php 378,310.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 04 April 2022 and was attended by a prospective bidder:

1. Segaya Builders International, Inc.
2. Technosure Electronics
3. Uptown Industrial Sales
4. Iloilo Izeem Commercial

WHEREAS, in response to the said posting, four (4) prospective bidders purchased the bidding documents:

1. Hans Office Supply and Office Equipment Merchandising
2. WYZ Watch
3. ELM Industrial Sales
4. Segaya Builders International, Inc.

WHEREAS, only two (2) prospective bidders submitted their bid proposals within the deadline set on 18 April 2022 at 5pm, to wit:

1. Hans Office Supply and Office Equipment Merchandising
2. ELM Industrial Sales

WHEREAS, WYZ Watch and Segaya Builders International, Inc. were unable to submit their bid proposals;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, three (3) bidders was declared "passed" during the preliminary examination of bids, to wit:

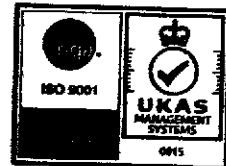
