BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF GENERAL SERVICES AND MAINTENANCE FOR PDAS
Project Reference No. ISAT U GOODS- 2022-03-23

RESOLUTION NO. 377, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of General Services and Maintenance for PDAS** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **24 March 2022**. The total Approved Budget for the Contract (ABC) of **Three Million Three Hundred Forty Eight Thousand Two Hundred Eighty Four Pesos and 64/100 (PhP 3,348,284.64)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 4 April 2022 and was attended by the following prospective bidders:

1. Pacific Sun Manpower
2. Royal 88 Manpower Services
3. Tekton Entre-Workers Cooperative Iloilo

WHEREAS, in response to the said posting, three (3) prospective bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 18 April 2022, to wit:

1. Pacific Sun Manpower
2. Royal 88 Manpower Services
3. Tekton Entre-Workers Cooperative Iloilo

WHEREAS, during the opening of bids held on 19 April 2022, the three (3) bidders were declared "passed" during the preliminary examination of bids;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

WHEREAS, as per GPPB Circular No. 02-2010 (3.3), the computation of Bid as Read and as Calculated with VAT inclusion is for the purpose to ensure that all bids shall be evaluated on equal footing, all taxes itemized by non-cooperatives in their bid and which cooperatives are tax exempt shall be added to the bid of cooperatives strictly for purposes of evaluation and comparison;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

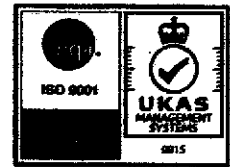
