WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF OFFICE FURNITURE EQUIPMENT FOR CAS on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of Three Hundred Thirty-Five Thousand Six Hundred Pesos (PhP 335,600.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **04 August 2022** and only Progress Home and Office Furnitures in attendance;

WHEREAS, in response to the said posting, only two (2) prospective bidder purchased the bidding documents:

- 2. Strides PEF Enterprises

WHEREAS, two (2) submitted their bid proposals within the deadline set on 17 August 2022 at 5pm, to wit:

- 1. Anzeca's Home & Office Furniture
- 2. Strides PEF Enterprises

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, all declared "passed" during the Opening of Bids held on **August 18**, **2022** and preliminary examination of bids, to wit;
