

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF SECURITTY SERVICES FOR SSEDMMO

RESOLUTION NO. 702, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF SECURITY SERVICES FOR SSEDMMO on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of Seven Million Three Hundred Thirty-Two Thousand Pesos (PhP 7,332,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **09 August 2022** and three (3) prospective bidders in attendance:

- 1. Gran Royale Security
- 2. Mount Carmel Security Agency
- 3. Stelsen Security Agency

WHEREAS, in response to the said posting, three (3) prospective bidder purchased the bidding documents:

- 1. Stelsen Security Agency Corp.
- 2. Mt. Carmel Security Agency Corp.
- 3. D'Redeemer Security Agency Corp.

WHEREAS, three (3) submitted their bid proposals within the deadline set on 22 August 2022 at 5pm, to wit:

- 1. Stelsen Security Agency Corp.
- 2. Mt. Carmel Security Agency Corp.
- 3. D'Redeemer Security Agency Corp.

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, two (2) declared "passed" during the Opening of Bids held on **August 23**, **2022** and preliminary examination of bids, to wit;
