BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS PAPER SUPPLIES FOR UNIVERSITY OFFICES Project Reference No. ISAT U GOODS- 2022-09-086

RESOLUTION NO. 822, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF VARIOUS PAPER SUPPLIES FOR UNIVERSITY OFFICES on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of Two Million Two Hundred Twenty-Six Thousand Eight Hundred Ninety-Three Pesos (PhP 2,226,893.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **11 October 2022** and three (3) prospective bidders in attendance:

- 2. Strides PEF Enterprises
- 3. Persabe Merchandising
- 4. ELM Industrial Sales

WHEREAS, in response to the said posting, three (3) prospective bidder purchased the bidding documents:

- ROG Enterprises
- 2. Strides PEF Enterprises
- 3. Armix Copier Rentals Services and Sales

WHEREAS, three (3) submitted their bid proposals within the deadline set on October 22, 2022 at 5pm, to wit:

- 1. ROG Enterprises
- 2. Strides PEF Enterprises
- 3. Armix Copier Rentals Services and Sales

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, two (2) declared "passed" during the Opening of Bids held on October 24, 2022 and preliminary examination of bids, to wit;

To declare that ROG ENTERPRISES, as the Lowest Calculated and Responsive Bid (LCRB) for the PROCUREMENT OF VARIOUS PAPER SUPPLIES FOR UNIVERSITY OFFICES and awarded the contract in the total amount of One Million Four Hundred Sixty-Five Thousand One Hundred Eleven Pesos and Forty-Five Centavos (PhP 1,465,111.45) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
