

BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF IT EQUIPMENT FOR CAS Project Reference No. ISAT U GOODS - 2022-10-106

RESOLUTION NO. 891, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF IT EQUIPMENT FOR CAS** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos (PhP 1,500,000.00)** inclusive of applicable taxes, "short of award";
