## BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PRINTING OF FORMS FOR UNIVERSITY REGISTRAR

RESOLUTION NO. 12 , s. 2023

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PRINTING OF FORMS FOR UNIVERSITY REGISTRAR** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Seven Hundred Eighty-Three Thousand Pesos (PhP 783,000.00)** inclusive of applicable taxes, "Short of award";

**WHEREAS,** a Pre-Bid Conference was held on **February 9, 2023** and there were four (4) prospective bidders in attendance:

- 3. Makinaugalingon Printer & Bookbinder
- 4. Armix Copier Rentals Services & Sales

**WHEREAS,** in response to the said posting, there were five (5) prospective bidder purchased the bidding documents:

- 1. Panorama Printing, Inc.
- 2. JGH Business Solutions
- 3. Makinaugalingon Printer & Bookbinder
- 4. Iloilo Printing & Services
- 5. Malones Printing Press & Publishing House

**WHEREAS**, five (5) prospective bidders submitted their bid proposals within the deadline set on **February 20, 2023** at 5pm, to wit:

- 1. Panorama Printing, Inc.
- 2. JGH Business Solutions
- 3. Makinaugalingon Printer & Bookbinder
- 4. Iloilo Printing & Services
- 5. Malones Printing Press & Publishing House

**WHEREAS**, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

**WHEREAS,** only two (2) were declared "passed" during the Opening of Bids held on **February 21, 2023** and preliminary examination of bids, to wit;
