



**INVITATION TO BID FOR THE
PROCUREMENT OF NETWORKING LICENSES
(ANNUAL LICENSE RENEWAL) FUND 164**

1. The Iloilo Science and Technology University (ISAT U), through the Fund 164 intends to apply the sum of **PhP 300,000.00** being the ABC to payments under the contract for **ISAT U GOODS-2021-03-036**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Iloilo Science and Technology University (ISAT U) now invites bids for the **Procurement of Networking Licenses (Annual License Renewal)** with a **contract duration of one (1) year**. Bidders should have completed, **within the last 5 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. **Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.**

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **Iloilo Science and Technology University (ISAT U)** and inspect the Bidding Documents at the address given below during office hours at **8am to 5pm from Mondays to Fridays**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 24 to April 5, 2021** from the given address stated below and upon payment of applicable fee for the said Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Hundred Pesos (PhP 500.00)** only.
6. The Iloilo Science and Technology University (ISAT U) will hold a Pre-Bid Conference on **March 23, 2021 @ 1:30pm** at the **BAC Conference Room of ISAT-U** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before, **April 5, 2021 at 5PM**.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**. Late bids shall not be accepted.
9. Bid opening shall be on **April 6, 2021 @ 1:30pm** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Iloilo Science and Technology University (ISAT U) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
