**BAC RESOLUTION DECLARING DLC ELECTRO MECHANICAL ENGINEERING SERVICES AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARDING OF CONTRACT AND NOTICE TO PROCEED WITH THE PREVENTIVE MAINTENANCE OF TWO (2) UNITS PASSENGER ELEVATOR AT THE RESEARCH HUB BUILDING AND CEA-ICT BUILDING, F-101 THROUGH NEGOTIATED PROCUREMENT**

**BAC RESOLUTION NO. 38, s. 2021**

WHEREAS, the Iloilo Science and Technology University, through the Bids and Awards Committee (BAC) posted the Invitation to Bid for the Preventive Maintenance of Two (2) Units Passenger Elevator at the Research Hub Building and CEA-ICT Building, F-101 with an Approved Budget for the Contract (ABC) of PhP 180,000.00 on the PhilGeps, ISAT U Website and in the conspicuous place in the premises of the University;

WHEREAS, a public bidding was conducted on March 8, 2021 and on March 30, 2021 where prospective bidders failed to submit their bids, hence a failure of bidding was declared;

WHEREAS, under Sec. 35.5 of the 2016 Revised Implementation Rules and Regulations (IRR) of Republic Act 9184 (RA 9184) should there occur a second failure of bidding, the Procuring Entity may resort to Negotiated Procurement as provided for in Sec. 53.1 of this IRR;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder applied for eligibility and bought bid documents;

WHEREAS, basis of awarding should be on a one lot basis;

WHEREAS, during the Opening of Bids of the best and final offer conducted on June 29, 2021, proper scrutiny and bid evaluation were conducted by the BAC and TWG members on the bid documents submitted by the lone bidder, where result showed that it was found to be eligible and had complied with the bidding requirements;

WHEREAS, opening of bids through negotiated procurement had this result:

WHEREAS, a bid evaluation, verification and post-qualification was conducted by the members of the BAC and TWG on the eligibility and technical requirements submitted by **DLC ELECTRO MECHANICAL ENGINEERING SERVICES** where result showed that it was found to be responsive;

NOW THEREFORE, we, the members of the Bids and Awards Committee RESOLVE, as it is hereby RESOLVED:

- a. to declare **DLC ELECTRO MECHANICAL ENGINEERING SERVICES** as the Single Calculated Responsive Bid (SCRB) and for complying the technical specifications set by the Technical Working Group (TWG) and End-user with the Preventive Maintenance of Two (2) Units Passenger Elevator at the Research Hub Building and CEA-ICT Building, F-101;
- b. that the said supplier had complied with all the necessary pre-requisite requirements for undertaking the procurement contract as stipulated under existing laws and policies.
- c. that the Bids and Awards Committee (BAC) shall recommend to the University President the approval of the Awarding of Contract and Notice to Proceed with the Preventive Maintenance of Two (2) Units Passenger Elevator at the Research Hub Building and CEA-ICT Building, F-101;
- d. that the said supplier be made aware that the University reserves the right to suspend or cancel the said award in case of irregularities or fraud committed by the supplier.
