INVITATION FOR NEGOTIATED PROCUREMENT

***PREVENTIVE MAINTENANCE OF TWO (2) UNITS PASSENGER
ELEVATOR AT RESEARCH HUB BUILDING AND CEA-ICT
BUILDING FUND 101***

1. The Iloilo Science and Technology University (ISAT U), through the Fund 101 intends to apply the sum of **PhP 180,000.00** being the ABC to payments under the contract for ISAT U GOODS-2021-02-031. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. ISAT U will hold a meeting with all interested bidders on **June 17, 2021 at 10am**. To reduce the risks and hazards of community transmission of COVID-19, the BAC will allow only **one (1) authorized representative** from each prospective bidders and should exercise all the necessary precautionary measures while inside the University.
3. The Eligibility Documents, Technical Proposal, and Best and Final Offer stated in the checklist shall be submitted in one (1) original and two (2) duplicate copies on or before **June 28, 2021 at 5pm**, at the Bids and Awards Committee (BAC) Office, Iloilo Science and Technology University, Burgos St., La Paz, Iloilo City.

The BAC shall conduct the meeting for the opening of Eligibility Documents, Technical Proposal, and Best and Final Offer on **June 29, 2021, 10am**, at HRT Service Center, Iloilo Science and Technology University, Burgos St., La Paz, Iloilo City.

Only interested bidders who paid the fee in the amount of **Five Hundred Pesos (PhP 500.00)** shall have their best and final offers opened. Best and final offers received in excess of the ABC shall be automatically rejected.

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Within one (1) calendar year from notice, the bidder whose submission is determined as the Lowest Calculated Quotation shall submit its latest Income Tax Return (ITR) and its VAT returns (Forms 2250M and 2550Q) or Percentage Tax Return (Form 2551M), with proofs of payment files and paid through the Electronic Filing and Payment System.
6. Prospective Bidders may obtain further information from **Iloilo Science and Technology University (ISAT U)** and inspect the Bidding Documents at the address given below during office hours at **8am to 5pm from Mondays to Fridays**.
7. The **Iloilo Science and Technology University (ISAT U)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
