

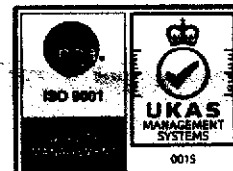

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE EXTENSION OF FABRICATION LABORATORY (FABLAB)
Project Reference No. ISAT U INFRA - 2022-01-03

RESOLUTION NO. 59, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for **EXTENSION OF FABRICATION LABORATORY (FABLAB)** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **08 December 2021**. The total Approved Budget for the Contract (ABC) of **Five Thousand Eight Hundred Sixty Four Thousand Three Hundred Nine Pesos and 53/100 (PhP 5,864,309.53)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 14 December 2021 and was attended by the following prospective bidders:

1. Capricorn General Merchandising and Services
2. Reeg Airconditioning & Automatic Fire Sprinkler System and Installation Services
3. Topmost Development & Marketing Corporation
4. Urbancon Builders & Supply
5. GSMAXX Construction
6. JFJ Construction & Supply, Inc.
7. F&T Construction & Supply
8. NEM Construction Supplies and Services
9. NOE's Builders

WHEREAS, in response to the said posting, four (4) prospective bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 24 December 2021, to wit:

1. JFJ Construction & Supply, Inc.
2. F&T Construction & Supply
3. Energo Construction
4. NEM Construction Supplies and Services

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184

WHEREAS, three (3) bidders were declared "passed" during the preliminary examination of bids;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

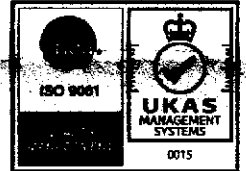

WHEREAS, under the 2016 Revised IRR of RA 9184 Section 25.6, it states that:

Section 25.6 Bids, including the eligibility requirements under Section 23.1 of this IRR, submitted after the deadline shall not be accepted by the BAC. The BAC shall record in the minutes of bid submission and opening, the bidder's name, its representative and the time the late bid was submitted or in case of online or electronic bid submission, generate a Bid receipt page for the official time of late submission which can be saved or printed by the bidder.

WHEREAS, the deadline for submission of bid was 24 December 2021 at 5pm;

WHEREAS, Ms. Ma. Concepcion A. Llejay, representative of NEM Construction Supplies & Services, was present during the opening of bids and confirmed that she submitted their bid documents on 26 December 2021 at 12:09PM which was received and dated by the guard on duty at the main entrance of the University;

WHEREAS, the BAC unanimously rejected the bid documents for late submission following Section 25.6 of the Revised IRR of RA 9184, and returned the bid documents of NEM Construction Supplies and Services;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

WHEREAS, under Section 34.4 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 or otherwise known as the "*Philippine Government Procurement Act*", it expressly provides that:

*If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB66, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, **whichever is lower** or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.*

WHEREAS, the Technical Working Group (TWG) is hereby recommending to award the contract to **JFJ Construction & Supply, Inc.** at its **Bid Amount as Calculated** which is lower than the Bid Amount as Calculated based on the actual results as follow:

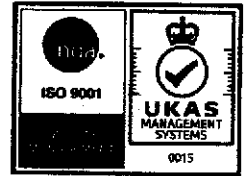
