PROCUREMENT OF ICT EQUIPMENT FUND 164

1. The Iloilo Science and Technology University (ISAT U), through the **Fund 164** intends to apply the sum of **PhP 3,220,040.00** being the ABC to payments under the contract for **ISAT U GOODS-2021-07-065**. Bids received in excess of the ABC shall be automatically rejected at bid opening. The procurement mechanism to be used is **"BY LOT"**.
2. To reduce the risks and hazards of community transmission of COVID-19, the BAC will conduct its procurement activities via Google Meet. To join the said activities, please access the link below:

3. **ISAT U will hold its Negotiation Proper with all interested bidders on November 18, 2021 at 9:30am.**
4. The Eligibility Documents, Technical Proposal, and Best and Final Offer stated in the checklist shall be submitted in one (1) original and two (2) duplicate copies on or before **November 29, 2021 at 5pm**, at the Bids and Awards Committee (BAC) Office, Iloilo Science and Technology University, Burgos St., La Paz, Iloilo City.
5. The BAC shall conduct the meeting for the **Opening of Eligibility Documents, Technical Proposal, and Best and Final Offer on December 1, 2021, 9:30am.**
6. Only interested bidders who paid the fee in the amount of **Three Thousand Five Hundred Pesos (PhP 3,500.00)** shall have their best and final offers opened. Best and final offers received in excess of the ABC shall be automatically rejected.
7. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
8. Within one (1) calendar year from notice, the bidder whose submission is determined as the Lowest Calculated Quotation shall submit its latest Income Tax Return (ITR) and its VAT returns (Forms 2250M and 2550Q) or Percentage Tax Return (Form 2551M), with proofs of payment files and paid through the Electronic Filing and Payment System.
9. Prospective Bidders may obtain further information from **Iloilo Science and Technology University (ISAT U)** and inspect the Bidding Documents at the address given below during office hours at **8am to 5pm from Mondays to Fridays**.
10. The **Iloilo Science and Technology University (ISAT U)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
