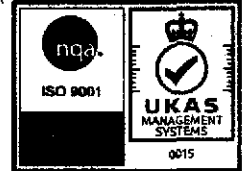

**BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB)
AND RECOMMENDING AWARD FOR THE
PROCUREMENT OF RFID FOR SECURITY GATE SYSTEM FUND 164**
Project Reference No. **ISAT U GOODS-2022-01-09**

RESOLUTION NO. 201, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for **PROCUREMENT OF RFID FOR SECURITY GATE SYSTEM FUND 164** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **5 February 2022**. The total Approved Budget for the Contract (ABC) of **Three Thousand Pesos (PhP 3,000,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, under the 2016 Revised IRR of RA 9184 Section 25.6, it states that:

Section 25.6 Bids, including the eligibility requirements under Section 23.1 of this IRR, submitted after the deadline shall not be accepted by the BAC. The BAC shall record in the minutes of bid submission and opening, the bidder's name, its representative and the time the late bid was submitted or in case of online or electronic bid submission, generate a Bid receipt page for the official time of late submission which can be saved or printed by the bidder.

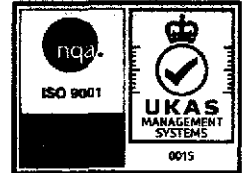

WHEREAS, Ms. Sanlor Demonteverde, representative of MegaText Philippines, Inc., was present during the opening of bids and confirmed that she submitted their bid documents on 28 February 2022 at 9:06am which was received by the guard on duty of the University;

WHEREAS, the opening of bids was conducted on 28 February 2022;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, the BAC had the following findings:

WHEREAS, during Eligibility Screening, the submission of the eligibility documents enumerated in Section 23.1 of the 2016 IRR of RA No. 9184 is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the 2016 IRR.

WHEREAS, **Wiserf Technologies, Inc.** was declared "passed" during the preliminary examination of bids;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

To declare that **WISERF TECHNOLOGIES, INC.**, as the **Single Calculated and Responsive Bid (SCRB)** for the **PROCUREMENT OF RFID FOR SECURITY GATE SYSTEM FUND 164** and awarded the contract in the total amount of **One Million One Hundred Eighty Thousand Eight Hundred Pesos (PhP 1,180,800.00)** inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.

Resolved at the City of Iloilo this 24th day of March, 2022.

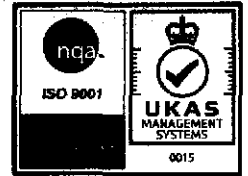
