

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF ALL-IN-ONE COMPUTER FOR THE FIBER OPTICS BACKBONE AND ENHANCEMENT OF VIRTUAL LEARNING ENVIRONMENT

RESOLUTION NO. 202, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for **PROCUREMENT OF ALL-IN-ONE COMPUTER FOR THE FIBER OPTICS BACKBONE AND ENHANCEMENT OF VIRTUAL LEARNING ENVIRONMENT** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **5 February 2022**. The total Approved Budget for the Contract (ABC) of **Five Million One Hundred Twenty Eight Thousand Six Hundred Fifty Pesos (PhP 5,128,650.00)** inclusive of applicable taxes, "short of award";

WHEREAS, in response to the said posting, three (3) prospective bidders purchased the bidding documents and submitted its bid on the deadline, 25 February 2022 at 5pm, namely:

WHEREAS, the opening of bids was conducted on 28 February 2022;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, the BAC had the following findings:

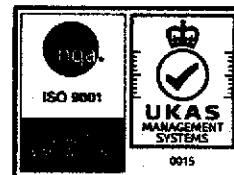

WHEREAS, during Eligibility Screening, the submission of the eligibility documents enumerated in Section 23.1 of the 2016 IRR of RA No. 9184 is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the 2016 IRR.

WHEREAS, **Microgenesis Business System** and **Oxord Computer Solutions and Repair Center** were declared "passed" during the preliminary examination of bids;

WHEREAS, **Clipdata Computer Center** was declared "failed" and disqualified for failure to meet the technical specifications on storage;

WHEREAS, **Clipdata Computer Center** expressed its intention to file a Motion for Reconsideration but was unable to submit it within the prescribed period provided under Section 55.1 of RA 9184 and its 2016 Revised IRR;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

NOW, THEREFORE, the foregoing premises considered, **WE**, the Members of ISAT U Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a. To declare that **MICROGENESIS BUSINESS SYSTEM**, as the **Lowest Calculated and Responsive Bid (LCRB)** for the **PROCUREMENT OF ALL-IN-ONE COMPUTER FOR THE FIBER OPTICS BACKBONE AND ENHANCEMENT OF VIRTUAL LEARNING ENVIRONMENT** and awarded the contract in the total amount **Four Million Six Hundred Thirty Eight Thousand Eight Hundred Forty Pesos (PhP 4,638,840.00)** inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.

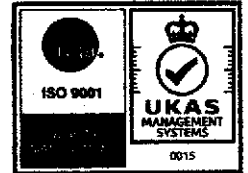

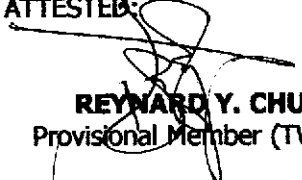

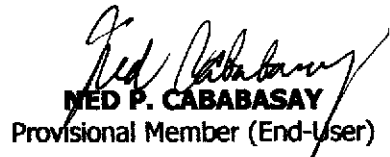
