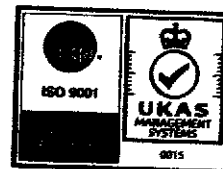

BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF NETWORKING RENEWAL LICENSES FOR MIS/EDP
 Project Reference No. **ISAT U GOODS-2022-03-021**

RESOLUTION NO. 322, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for **PROCUREMENT OF NETWORKING RENEWAL LICENSES FOR MIS/EDP** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **24 March 2022**. The total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Seventy Eight Thousand Pesos (PhP 1,778,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 4 April 2022 and were attended by the following prospective bidders:

1. Microgenesis Business Systems
2. Technosure Electronics

WHEREAS, in response to the said posting, only Microgenesis Business Systems purchased the bidding documents and submitted its bid offer on the deadline, 18 April 2022 at 5pm;

WHEREAS, the Opening of Bids was conducted on 19 April 2022;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, the BAC had the following findings:

WHEREAS, during Eligibility Screening, the submission of the eligibility documents enumerated in Section 23.1 of the 2016 IRR of RA No. 9184 is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the 2016 IRR.

WHEREAS, **Microgenesis Business System** was declared "passed" during the preliminary examination of bids;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

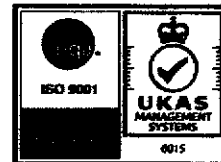
