

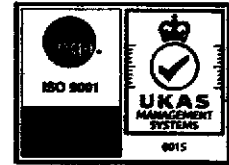

**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
AND RECOMMENDING AWARD FOR THE PROCUREMENT OF JANITORIAL SUPPLIES**
Project Reference No. ISAT U GOODS- 2022-03-020

RESOLUTION NO. 371, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF JANITORIAL SUPPLIES** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **24 March 2022**. The total Approved Budget for the Contract (ABC) of **Two Hundred Twelve Thousand Six Hundred Seventy Pesos (PhP 212,670.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 04 April 2022 and was attended by a prospective bidder:

1. Segaya Builders International, Inc.
2. Technosure Electronics
3. Uptown Industrial Sales
4. Iloilo Izeem Commercial

WHEREAS, in response to the said posting, four (4) prospective bidders purchased the bidding documents:

1. Hans Office Supply and Office Equipment Merchandising
2. Zurxes Marketing
3. ELM Industrial Sales
4. Segaya Builders International, Inc.

WHEREAS, only three (3) prospective bidders submitted their bid proposals within the deadline set on 18 April 2022 at 5pm, to wit:

1. Hans Office Supply and Office Equipment Merchandising
2. ELM Industrial Sales
3. Zurxes Marketing

WHEREAS, Segaya Builders International, Inc. was unable to submit their bid proposals;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, three (3) bidders was declared "passed" during the preliminary examination of bids, to wit;

Hans Office Supply and Office Equipment Merchandising	PhP 188,118.00
Zurxes Marketing	Disqualified.

WHEREAS, pursuant to Section 23.1 of the 2016 IRR of RA No. 9184 is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the 2016 IRR.;

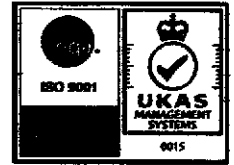

WHEREAS, Zurxes Marketing was disqualified due to non-compliance or failure to provide its Single Largest Completed Contract (SLCC) and technical specifications in its bid proposal;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:

- To declare that **ELM MERCHANDISING**, as the **Lowest Calculated and Responsive Bid (LCRB)** for the **PROCUREMENT OF OFFICE SUPPLIES** and awarded the contract in the total amount of **One Hundred Eighty Seven Thousand Seven Hundred Nineteen Pesos (PhP 187,719.00)** inclusive of applicable taxes; and
- To recommend for approval of the University President the foregoing findings.
