

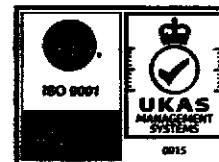

BAC RESOLUTION DECLARING CLIPDATA COMPUTER CENTER AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER AND RECOMMENDING AWARD FOR THE PROCUREMENT OF LAPTOP FOR ELECTRONICS AND ELECTRICAL DEPARTMENT
Project Reference No. ISAT U GOODS 2022-01-010

RESOLUTION NO. 336, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for **PROCUREMENT OF LAPTOP FOR ELECTRONICS AND ELECTRICAL DEPARTMENT** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **10 MARCH 2022**. The total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Thousand Pesos (PhP 1,700,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 17 March 2022 and was attended by the following prospective bidders:

1. Pronet System – Cebu
2. Oxord Computer Solutions
3. Mustard Seed Systems Corp.
4. Microgenesis Business Systems
5. Clipdata Computer Center

WHEREAS, in response to the said posting, three (3) prospective bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 28 March 2021, to wit:

1. Clipdata Computer Center
2. Circle Compubiz
3. HYW IT Distributors

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184

WHEREAS, all three (3) bidders were declared "passed" during the preliminary examination of bids;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

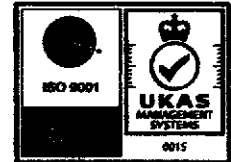

WHEREAS, on 01 April 2022, representatives from the BAC, TWG and BAC Secretariat, conducted its post qualification with Circle Compubiz;

WHEREAS, pursuant to 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 or otherwise known as the "Government Procurement Reform Act" Section 34, the Bids and Awards Committee verifies, validates and ascertains all statements made and the documents submitted by the bidder with Lowest Calculated Bid (LCB) or Highest Rated Bid (HRB), as the case may be, using non-discretionary pass/fail criteria. The verification under the post-qualification stage is not limited to the examination of documents submitted by the bidder, but also includes inspection of the subject equipment vis-à-vis the technical specifications specified in the bidding documents;

WHEREAS, on 06 April 2022, Circle Compubiz received a letter from ISAT U BAC for clarification of its bid pursuant to Section 32.1 of RA 9184 and its 2016 Revised IRR;

WHEREAS, on 06 April 2022 @ 1:53pm, Circle Compubiz submitted a counter-offer;

WHEREAS, on 11 April 2022, Circle Compubiz received a letter from ISAT U BAC requesting it to submit additional technical specifications of the items it offered specifically during the Opening of Bids as per Section 34 of RA 9184 as its 2016 Revised IRR;

WHEREAS, on 12 April 2022, Circle Compubiz submitted its compliance;

WHEREAS, based on the findings and report of the Technical Working Group (TWG), it has a reasonable ground to declare the bidder non-compliant for failure to meet the technical specifications on Bluetooth and battery;

WHEREAS, pursuant to 2016 Revised IRR of RA 9184 on Section 55.1, it provides:

Section 55.1 Decisions of the BAC at any stage of the procurement process may be questioned by filing a request for reconsideration within the three (3) calendar days upon receipt of written notice or upon verbal notification. The BAC shall decide on the request for reconsideration within seven (7) calendar days from receipt thereof. xxx

WHEREAS, on 27 April 2022, Ms. Charmae Lynn Tinasas, a representative from Circle Compubiz, received the Notice of Post-Disqualification and failed to file its Motion for Reconsideration within the period prescribed by RA 9184;

WHEREAS, Circle Compubiz was declared **post-disqualified**;

WHEREAS, for justifiable causes, the bidder with the Lowest Calculated Responsive Bid or Highest Rated Responsive Bid fails xxx to enter into contract with the Procuring Entity, xxx the BAC shall disqualify the said bidder and shall undertake post-qualification for the next-ranked Lowest Calculated Bid or Highest Rated Bid. This procedure shall be repeated until an award is made. However, if no award is possible, the contract shall be subjected to a new bidding as provided under Section 40 of the 2016 Revised IRR of RA 9184;

WHEREAS, **Clipdata Computer Center** has the next-ranked Lowest Calculated Bid;

WHEREAS, representatives from the BAC, TWG and the BAC Secretariat conducted its post qualification with Clipdata Computer Center on 13 May 2022;

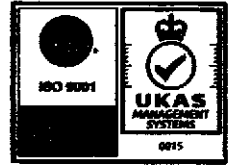

NOW, THEREFORE, the foregoing premises considered, **WE**, the Members of ISAT U Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a. To declare that **Clipdata Computer Center**, has the **LOWEST CALCULATED AND RESPONSIVE BID** for the **PROCUREMENT OF LAPTOP FOR ELECTRONICS AND ELECTRICAL DEPARTMENT** and awarded the contract in the total amount of **One Million Five Hundred Thirty Three Thousand Five Hundred Seventy Pesos (PhP 1,533,570.00)** inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
