

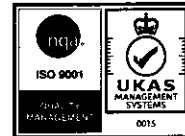

**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
AND RECOMMENDING AWARD FOR THE PRINTING OF UNIVERSITY STUDENT CODE OF
DISCIPLINE FOR OSAS DEPARTMENT**

RESOLUTION NO. 437, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PRINTING OF UNIVERSITY STUDENT CODE OF DISCIPLINE FOR OSAS DEPARTMENT** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days, starting on **27 May 2022**. The total Approved Budget for the Contract (ABC) of **Three Hundred Seventy-Five Thousand Pesos (Php 375,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on 02 June 2022 and was attended by a prospective bidder:

WHEREAS, in response to the said posting, six (6) prospective bidders purchased the bidding documents:

4. PANORAMA PRINTING INC.
5. HOMETOWN PRINTING PRESS
6. JGH BUSINESS SOLUTIONS

WHEREAS, all six (6) prospective bidders submitted their bid proposals within the deadline set on 13 June 2022 at 5pm, to wit:

2. ILOILO PRINTING AND SERVICES
3. MAKINAUGALINGON PRINTER AND BOOKBINDER
4. PANORAMA PRINTING INC.
5. HOMETOWN PRINTING PRESS
6. JGH BUSINESS SOLUTIONS

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

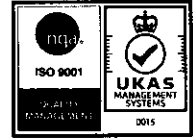
