



**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF MEDICAL SUPPLIES FOR SSEDMMO**

**WHEREAS**, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF MEDICAL SUPPLIES FOR SSEDMMO** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Nine Hundred Eighty-Seven Thousand Eight Hundred Pesos (PhP 987,800.00)** inclusive of applicable taxes, "short of award";

**WHEREAS**, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

**WHEREAS**, two (2) declared "passed" during the Opening of Bids held on **October 3, 2022** and preliminary examination of bids, to wit;


