WHEREAS, two (2) declared "passed" during the Opening of Bids held on **August 16, 2022** and preliminary examination of bids, to wit;

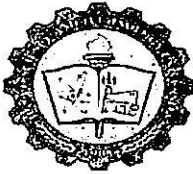
