

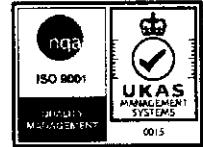

**BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB)
AND RECOMMENDING AWARD FOR THE REPAIR AND MAINTENANCE FOR
RENOVATION OF ELT/TRC LAB WITH TRC OFFICE AND PANTRY
Project Reference No. ISAT U INFRA - 2022-10-09**

RESOLUTION NO. 880, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **REPAIR AND MAINTENANCE FOR RENOVATION OF ELT/TRC LAB WITH TRC OFFICE AND PANTRY** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Two Hundred Six Thousand Twenty-Eight Pesos and Six Centavos (PhP 206,028.06)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **26 October 2022** and no prospective bidders in attendance;

WHEREAS, in response to the said posting, **Energo Construction** was the only bidder purchased the bidding documents;

WHEREAS, **Energo Construction** submitted their bid proposals within the deadline set on **November 9, 2022** at 5pm;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, **Energo Construction** was declared "passed" during the Opening of Bids held on **November 10, 2022** and preliminary examination of bids, to wit;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:


- a. To declare that **ENERGO CONSTRUCTION**, as the **Single Calculated and Responsive Bid (SCRB)** for the **REPAIR AND MAINTENANCE FOR RENOVATION OF ELT/TRC LAB WITH TRC OFFICE AND PANTRY** and awarded the contract in the total amount of **Two Hundred Four Thousand Six Hundred Five Pesos and Eighty-Nine Centavos (PhP 204,605.89)** inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
