

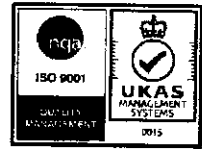

**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
 AND RECOMMENDING AWARD FOR THE PROCUREMENT OF LABORATORY EQUIPMENT
 FOR CEA**

RESOLUTION NO. 884, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF LABORATORY EQUIPMENT FOR CEA** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Nine Hundred Thousand Pesos (PhP 900,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **19 October 2022** and three (3) prospective bidders in attendance;

1. Hinoki Global Concepts, Inc.
2. Prince Valiant Int'l Corp.
3. Winterfield Marketing.

WHEREAS, in response to the said posting, two (2) prospective bidder purchased the bidding documents:

1. NCO General Merchandise
2. Prince Valiant Int'l Corp.

WHEREAS, two (2) submitted their bid proposals within the deadline set on **November 3, 2022** at 5pm, to wit:

1. NCO General Merchandise
2. Prince Valiant Int'l Corp.

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, two (2) declared "passed" during the Opening of Bids held on **November 4, 2022** and preliminary examination of bids, to wit;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

To declare that **NCO GENERAL MERCHANDISE**, as the **Lowest Calculated and Responsive Bid (LCRB)** for the **PROCUREMENT OF LABORATORY EQUIPMENT FOR CEA** and awarded the contract in the total amount of **Seven Hundred Twenty-Eight Thousand Pesos (PhP 728,000.00)** inclusive of applicable taxes; and

b. To recommend for approval of the University President the foregoing findings.


