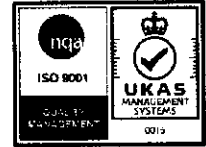

**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
AND RECOMMENDING AWARD FOR THE PROCUREMENT OF JANITORIAL SUPPLIES FOR
UNIVERSITY OFFICES**

RESOLUTION NO. 868, s. 2022

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF JANITORIAL SUPPLIES FOR UNIVERSITY OFFICES** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Two Million Two Hundred Fifty-Seven Thousand Three Hundred Seventy-Five Pesos (PhP 2,257,375.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **11 October 2022** and four (4) prospective bidders in attendance;

1. ROG Enterprises
2. Strides PEF Enterprises
3. Persabe Merchandising
4. ELM Industrial Sales

WHEREAS, in response to the said posting, seven (7) prospective bidder purchased the bidding documents:

1. ELM Industrial Sales
2. ROG Enterprise
3. Strides PEF Enterprises
4. Iloilo Izeem Commercial
5. Blue Mountain Safety & Industrial Products
6. Armix Copier Rentals Services and Sales
7. Iloilo Yca Dale Trading

WHEREAS, six (6) submitted their bid proposals within the deadline set on **October 22, 2022** at 5pm, to wit:

1. ELM Industrial Sales
2. ROG Enterprise
3. Strides PEF Enterprises
4. Iloilo Izeem Commercial
5. Blue Mountain Safety & Industrial Products
6. Armix Copier Rentals Services and Sales

WHEREAS, Iloilo Yca Dale Trading did not submit their bid proposals within the deadline set on **October 22, 2022** at 5pm;

WHEREAS, the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, three (3) declared "passed" during the Opening of Bids held on **October 24, 2022** and preliminary examination of bids, to wit;

WHEREAS, upon carefully checking the eligibility requirements of **Blue Mountain Safety and Industrial Products, Inc. & Uni-Art Supply, Inc.**, did not comply with the required technical specifications and declared the said bidder as "failed" under Section 30 of the Revised IRR of RA 9184;

WHEREAS, **Iloilo Izeem Commercial** did not indicate the supplemental bid/addendum in the technical specification form instead they attached the supplemental bid/addendum only and was also declared "failed";

WHEREAS, the **Iloilo Izeem Commercial** was the only failed bidder to signify their intention to file a motion for reconsideration as provided under Sec. 55.1 of this Act and submitted the said MR on the same **October 27, 2022**;

WHEREAS, upon careful deliberation and thorough discussion, the Committee unanimously resolved to **GRANT** the Request for Consideration of **Iloilo Izeem Commercial**;

WHEREAS, upon detailed evaluation of bid, it resulted in the following:

NOW, THEREFORE, the foregoing premises considered, **WE**, the Members of ISAT U Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a. To declare that **ROG ENTERPRISE**, as the **Lowest Calculated and Responsive Bid (LCRB)** for the **PROCUREMENT OF JANITORIAL SUPPLIES FOR UNIVERSITY OFFICES** and awarded the contract in the total amount of **One Million Six Hundred Thirty-Eight Thousand Seven Hundred Four Pesos and Fifty Centavos (PhP 1,638,704.50)** inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
