WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **PROCUREMENT OF CHAIR FOR UNIVERSITY REGISTRAR** on the website of the Philippine Government Electronic Procurement System (PhilGEPs), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of **Two Hundred Fifty Thousand Pesos (PhP 250,000.00)** inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on **February 9, 2023** and Progress Home and Office Furnishings was the only prospective bidder in attendance:

WHEREAS, two (2) were declared "passed" during the Opening of Bids held on **February 21, 2023** and preliminary examination of bids, to wit;
