

**CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_ between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "**ISAT U**") and **ILOILO PRINTING AND SERVICES** with office address at R. Mapa St., Old Airport Road, Mandurriao, Iloilo City, Philippines represented by its Owner, **MR. TEODORICO A. ANTIQUEÑA** (hereinafter referred to as the "**SUPPLIER**");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PRINTING OF COMMENCEMENT SOUVENIR PROGRAM FOR REGISTRAR** with Project Reference No. ISAT U GOODS – 2024 – 02 – 040 and has accepted a Bid by the **SUPPLIER** in the sum of **TWO HUNDRED THIRTY SIX THOUSAND THREE HUNDRED EIGHTY FIVE PESOS (PhP 236,385.00) ONLY**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **TWO HUNDRED THIRTY SIX THOUSAND THREE HUNDRED EIGHTY FIVE PESOS (PhP 236,385.00) ONLY** or such other sums as may be ascertained, the **ILOILO PRINTING AND SERVICES** agrees to supply and deliver printed **COMMENCEMENT SOUVENIR PROGRAM FOR REGISTRAR** in accordance with his/her/its Bid.
4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




