## CONTRACT AGREEMENT

NOEL D. LACHICA (hereinafter referred to as the "SUPPLIER");

- The ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
