

CONTRACT AGREEMENT

06 AUG 2024

THIS AGREEMENT, made this _____ day of _____, _____ between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "**ISAT U**") and **CHARLES OFFICE AND SCHOOL SUPPLIES** with office address at PhilAm Compound, Commission Civil Street, Jaro, Iloilo City, Philippines represented by its Proprietor, **MR. CHARLES A. PADERNAL** (hereinafter referred to as the "**SUPPLIER**");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF ATHLETIC SUPPLIES FOR PE AND SPORTS AFFAIRS** with Project Reference No. **ISAT U GOODS – 2024 – 02 – 036** and has accepted a Bid by the **SUPPLIER** in the sum of **EIGHT HUNDRED FIFTY SIX THOUSAND EIGHT HUNDRED TWENTY FOUR PESOS AND FORTY CENTAVOS (PhP 856,824.40) ONLY**, hereinafter called the "Contract Price".

4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
