

CONTRACT AGREEMENT

THIS AGREEMENT, made this 08 day of JUL, 2024 between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **M & B WHOLESALE & RETAILING ONLINE SHOP** with office address at Block 10 Lot 3 Jasmin St., Landheights Subd., Ph.1 Dulunan, Iloilo City, Philippines represented by its Owner, **MS. NIVEA MARIE VILLANUEVA** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF FURNITURE AND FIXTURES FOR FABLAB AND VPEA** with Project Reference No. ISAT U GOODS 2024 - 02 - 034 and has accepted a Bid by the **SUPPLIER** in the sum of **FIVE HUNDRED SIXTY NINE THOUSAND PESOS (PhP 569,000.00) ONLY**, hereinafter called the "Contract Price".

In consideration for the sum of **FIVE HUNDRED SIXTY NINE THOUSAND PESOS (PhP 569,000.00) ONLY** or such other sums as may be ascertained, the **M & B WHOLESALE & RETAILING ONLINE SHOP** agrees to supply and deliver various **FURNITURE AND FIXTURES FOR FABLAB AND VPEA** in accordance with his/her/its Quotation.
4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
