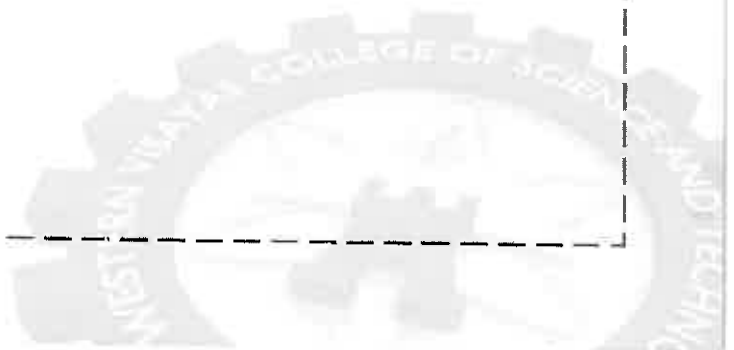

- 5. To develop leaders in the field of education, science and technology.*

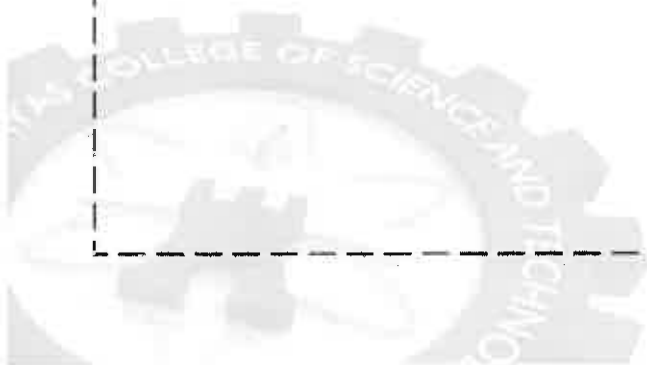

2009 ANNUAL REPORT EXECUTIVE SUMMARY

In its quest for excellence and universityhood, the Western Visayas College of Science and Technology has endeavored to achieve the following major accomplishments through the active leadership of Dr. Luis M. Sorolla, Jr., College President assisted by two Vice Presidents, Dr. Ricardo B. Abaleña, Vice President for Academic Affairs and Mr. Edwin T. Fos, Vice President for Administration and Finance.

These accomplishments were realized with the full cooperation of the faculty, staff, students and community leaders.

INSTRUCTION

Graduates

The College has produced 3,290 graduates for the school year 2008-2009 which is 2.7% higher than that of the previous school year. When broken down as to campuses 52.2% (1,719) of the graduates were from Main Campus, 27.9% (917) were from Miag-ao Campus (SIPC), 8.2% (271) were from Dumangas Campus (PDMC), 6.7% (222) were from Leon Campus (LNCA) and 4.9% (161) were from Barotac Nuevo Campus (DJSMMNC).

From these graduates, the School of Graduate Studies produced 8 graduates, 6 whom were from master's degree program and 2 from doctoral degree program.

Enrolment

The College has a total enrollees of 10,761 for the second semester 2009-2010 where 59.5% (6,404) were from Main Campus, 23.6% (2,543) were from Miag-ao Campus, 6.4% (691) were from Leon Campus (LNCA), 5.9% (637) were from Barotac Nuevo Campus and 4.5% (486) were from Dumangas Campus (PDMC).

This school year, the college enrolment relatively increased by 3.0%.

Students Development

To facilitate learning and capability enhancement, students were sent to various trainings/seminars/skills competitions such as culinary festival chef skills competition, cook-off challenge, patent drafting workshop, etc.

The College also conducted various activities for students development such as familiarization tours, on-premise catering, seminar-workshops on leadership and image enhancement, skills olympics, and Institutional and National Competency Assessments.

Faculty and Staff Development

To enhance the knowledge and skills and to become abreast with the current trends and issues in specific disciplines, faculty and staff were sent to various trainings and seminar-workshops in the local, regional and national levels.

Aside from the primary functions of the faculty members, they were also invited for their expert services in various events in the college and in other institutions. Some faculty members were also assigned as members of accreditation team in accrediting different SUCs.

The College provided support to the faculty and staff development through Faculty and Staff Development Plan scholarships and grants. In addition, two (2) engineering faculty were granted scholarships by CHED and DOST for graduate studies.

The Deans and Directors of the College attended the Junior Executive Training Workshop (JET) conducted by the PASUC VI in Northern Iloilo Polytechnic State College, Estancia, Iloilo last January 12-16, 2009. Furthermore, five (5) RAC faculty members passed the NC II examination which was conducted last October 2009 at Leon Ganson Polytechnic College.

In preparation for the AY 2009-2010, the Miag-ao Campus (SIPC) conducted their Annual Planning Workshop last May 20-21, 2009.

The SIPC Campus Administrator was re-elected as Member of the Board of Trustees for the Visayas of the Accrediting Agency of Chartered Colleges and Universities in the Philippines (AACCUP), Inc. He was also invited by CHED Region VI to be a member of the Regional Quality Assessment Team (RQUAT) to assess the capabilities of Tañon College, San Carlos City, Negros Occidental on February 21-22, 2009 in relation to their application for the recognition of Bachelor of Elementary Education (BEEd).

Curriculum Development

The final curriculum of BIT program was submitted together with the course description and newly added subject Occupational Safety and Health Practices.

Furthermore, revisions were made on the following Engineering programs: Bachelor of Science in Electronics Engineering (BSECE) was revised as per Resolution No. ACCO/2/19/09 – 2A, the Bachelor of Science in Electrical Engineering (BSEE) was revised as per Resolution No. ACCO/2/19/09 – 2B, and the Bachelor of Science in Mechanical Engineering major in Automotive Engineering (BSMEAE) was revised as per Resolution No. ACCO/2/19/09 – 21.

To ensure our continuous compliance with TESDA registration requirements of LEP and TVET courses and to increase the Pool of Accredited Competency Assessment and Certification Program, TESDA in Partnership with TESDA Supervised Schools Association of Iloilo, Inc. sent eleven (11) faculty to attend the Assessment Methodology 1 (AM1), Training Methodology 1 (TM1) and Assessment Course last February 5-13, 2009 at Amigo Terrace Hotel, Iloilo City and nine (9) faculty were sent for the Seminar-Workshop in UTRAS and Curriculum Development last February 25-26, 2009 in the same venue.

The Leon Campus (LNCA) implemented the ladderization of BS Agriculture curriculum.

With the Advocacy on One System One Standard Policy, the Dumangas Campus (PDMC) offered the Bachelor in Industrial Technology (BIT) which is a competency based curriculum. It has likewise submitted the proposed program on Information Technology NC III that conforms to TESDA program accreditation following the program offered at the Main Campus which eventually was approved by BOT for implementation.

The BOT also approved the proposal of Dumangas Campus to offer the NC IV (Programming) as the next competency level for those who are about to finish the NC II 9PC Operations. In addition, the proposal of the Dumangas Campus to offer the 3rd and 4th year ladderized program on Bachelor of Science in Information Technology patterned from the Main Campus was also approved.

Accreditation

The Doctor of Education program of the School for Graduate Studies was accredited by the AACUP team for Level I status on December 3-5, 2009 while the College of Industrial Technology prepared and reviewed the documents in preparation for the planned visit and submission of HRT documents in the Preliminary Survey.

The Bachelor of Science in Information Technology and Bachelor of Science in Computer Science programs underwent Preliminary Survey Visit by the AACUP last August 25-27, 2009. Likewise, the BS in Community Development submitted the Program Performance Profile (PPP) for Level III (2nd Survey) to AACUP-Manila for schedule visit by the Accreditors. It was accredited last November 20, 2009 with Dr. Manuel T. Corpus as the Team Leader together with Dr. Mariano J. Guillermo.

Furthermore, the Miag-ao Campus (SIPC) prepared their 5-year Accreditation Plan. This year, it has received the certificates issued by the Accrediting Agency of Chartered Colleges and Universities in the Philippines (AACUP), Inc., awarding the Level I Accredited Status for the Program Secondary Teacher Education from December 1, 2008 to November 30, 2011 and Candidate Status for the Program Information Technology from December 1, 2008 to November 30, 2010.

The Barotac Nuevo Campus (DJSMMNC) also prepared the necessary documents for the accreditation (Pre-survey) of the BSEd curriculum.

Awards Received

- One (1) Marine Engineering graduate of Miag-ao Campus (SIPC) garnered the 9th Place of the 10 highest successful examinees in the Second Engineering Licensure Examination (Written Phase) last January 2009.
- One (1) laboratory student was awarded as Champion in the Regional Cluster during the Secondary Press Conference
- Two (2) laboratory students were awarded 2009 Ten Outstanding Leaders of Iloilo City (TOSLIC)
- Two (2) education students who were members of the WVCST Arnis Team won the National Championship held in Manila
- A Bachelor of Science in Secondary Education student major in mathematics was chosen to be the Most Outstanding College Graduate of Class 2009
- Eleven (11) education students received academic awards
- Three (3) Architecture students won in the following competitions: *Grand Prize Winner* in 2009 Art Petron National Student Art Competition (Oil/Acrylic Category), *2nd Prize Winner* in 2009 Metrobank Art and Design Excellence (Oil Painting Category) and *3rd Place Winner* in the 42nd Shell National Student Art Competition (Water Color Category).
- Five (5) ECE students were hailed Champion in the Regional Elimination of the Bit the BEE's Electronics Engineering Interscholastic Quiz Show last October 2009.
- Two (2) CAS students won as overall Champion for 3 consecutive years in Arnis National Encounter at Mall of Asia in Pasig City last November 2009
- The Volleyball Men and Women of WVCST represented by PDMC bagged the first runner-up during the 2009 Regional State Colleges and Universities Athletic Association (SCUAA) Meet held at West Visayas State University, La Paz, Iloilo City.

Other Activities

- The School of Graduate Studies conducted an induction and forum in "The Making of World Class Professional" on August 15, 2009
- The college celebrated its 104th Foundation Anniversary with series of activities such as PAHAMPANG 2009, Computer Games Tournament, Department Exhibits, Quiz Bee Competition, Search for Miss WVCST, Cultural Presentation, Parade and Review and Pista sa COED (Fellowship Luncheon).
- An exhibition game in Table Tennis was held by the College ADCO Personnel.

RESEARCH

- Various colleges and satellite campuses of WVCST conducted an in-house review to evaluate completed researches and research proposals.
- Faculty researchers were sent to various research trainings, seminar-workshops and conferences in local, regional, national and international levels to enhance their research capability building and keep them updated with the new knowledge and issues towards R&D matters. The college faculty researchers also actively disseminated their research outputs through publication in reputable journals and paper presentations in different fora and conferences specifically in national and international levels. This is in line with the RSD's goal to improve the research capabilities of teachers and students to generate new knowledge and create new products and processes.
- The Research Services Division (RSD) has conducted *Planning Workshop for WVCST Research Programs* last July 28-29, 2009 with the invited resource speakers from DOST, CHED and NEDA. The workshop aimed to put in place the research activities at WVCST System for five years.
- The RSD also organized an *Inventors' Forum* last August 26, 2009 to disseminate the information that the College is into invention. The forum was participated in by the faculty, students from inventors' society and alumni inventors. There was sharing of best practices among the inventors and faculty.
- The RSD aims to achieve and maintain standards of global academic and technological excellence by enhancing the researchers' capabilities. Consonant to this goal, a three-day *Basic Intellectual Property Orientation and Patent Drafting Workshop* was conducted last October 20-22, 2009 at the EdTech Center, WVCST Main Campus participated in by fifty (50) faculty members and students from main and satellite campuses with invited speakers from the office of IP Philippines, Makati City. This orientation and workshop aimed to train the participants in prudent practices for preparing and prosecuting applications, specifications and claims for inventions and utility models.
- The College was this year's host of the Philippine Association of State Universities and Colleges (PASUC VI) *1st Regional Symposium on R&D* last November 19, 2009 at the EdTech Center. The symposium was highlighted by the presentation of research outputs of the 11 State Universities and Colleges (SUCs) in the region under four categories namely: Natural and Biological Science, Social Science, Environmental Science and Developmental.
- The Workload and de-loading policy for faculty researchers was approved during the Administrative Council (ADCO) Meeting last November 24, 2009 which applies to all faculty researchers from the main and satellite campuses who conduct research project(s). The objectives of this policy are: (1) to ensure that the workload and de-loading policy for researchers is consistent with the workload and overload guidelines of the College; (2) to elucidate the researchers' incentive scheme; and (3) to improve the overall research performance of the College.
- The Officer-in-Charge of the Research Services Division attended the World Intellectual Patent Office (WIPO) *International Seminar on Technology Transfer by Universities and Public Research Institutions through the Strategic Use of the Patent System* last December 9-11, 2009 at Colombo, Sri Lanka as paper presenter. He presented a paper about *Technology Transfer: Successful Cases and Challenges: The Philippine Experience*.
- There were thirteen (13) researches completed by the college faculty researchers this year. On-going Fit-Ed Research Projects funded by Worldlinks and the College are still in progress along with several on-going researches of the college faculty researchers.
- One (1) faculty researcher won Best Paper and 2nd Runner Up during the PASUC VI 1st Regional Symposium on R&D (Social Research Category).
- The RSD had the faculty writers' instructional materials copyrighted for protection. This year, 18 instructional materials were granted copyright with ISBN.
- The College had generated the gross income of Php 320,516.50 for the First Semester of SY 2009-2010 from the sale of Instructional Materials.
- The Research and Statistics Assistance Center (RSAC) managed by the RSD were able to serve 41 clients broken down as follows: 28 were undergraduate students, 8 were graduate students and 6 were non-WVCST clients. The RSAC generated a gross income of Php 20,535.00 from its various services such as consultancy, data encoding, reliability testing and statistical data analysis.
- The RSD developed the first semi-annual publication of research Newsletter.

EXTENSION

- The college extended supports to the community through Lectures, Livelihood Skills Training, Livelihood Capital Assistance, Mass Feeding and Medical/Dental Mission.
- The CAS extension program in Montes I and Montes II Elementary School was completed this January 2009.
- Launching Program of DOLE project with the title of "Suporta sa Manggagawang Kabataan, Kabuhayan para sa Magulang" in Partnership with the College of Industrial Technology and College of Engineering was held at Arevalo Elementary School on February 4, 2009.
- The Extension Services Division together with the different College of Extension Councils and SAVER conducted a feeding activity, medical/dental mission and bloodletting for our partner schools and barangays on July 23, 2009 at WVCST Covered Gym. These were sponsored by Sen. Manny Villar Foundation, WVCST Multi-Purpose Cooperative and Panay Power Corporation in cooperation with the DOH, PNRC, Iloilo Gardenia Lions Club, MESTO, COE-TLE and Alumni Dorm Residents.
- A NEGO CART Program with the partnership of DOLE was launched last November 3 and 4, 2009 at WVCST Covered Gym with Mr. Andres Ortega, Jr. as member of the Management Team.
- Two (2) garments faculty were assigned in-charge of the school uniform production of Panay Power Corporation and also conducted the making of tarpaulin bags to disabled persons of Iloilo City through the BBY (Breaking Barriers for Young Adults with Disabilities).
- The BFAT and RAC Department conducted the Skills Training in Bag/Envelope, Candle Making and Pots Designing last July 18-19, 2009 in cooperation with the Breaking Barriers of Youth to Persons with Disabilities and WVCST.
- The Leon Campus provided support to the community through swine dispersal project, seedlings dispersal, adopt-a-mountain program, adopt-a-barangay program, techno-demo farms, and livelihood and skills training.
- The Barotac Nuevo Campus (DJSMMNC) started the implementation of the SAVE ME "Save Mother Earth" Program.
- The Dumangas Campus through its Extension Office had undertaken the tutorial classes with the trainees and young boys under the care of Don Bosco Boy's Home and Vocational Training Center. The office in partnership with CWTS student volunteers, PNRC, Rotary Club of Dumangas, PTCA and the community had accomplished various activities including Blood Donation Campaign.
- The Extension office of Dumangas Campus spearheaded the launching activity and the signing of Memorandum of Understanding for "Buhayin ang Ilog Dumangas" with a goal of 10,000 trees by 2010 and the Solid Waste Management Program as joint projects of the Municipality of Dumangas and PDMC Civic Welfare Training Service.

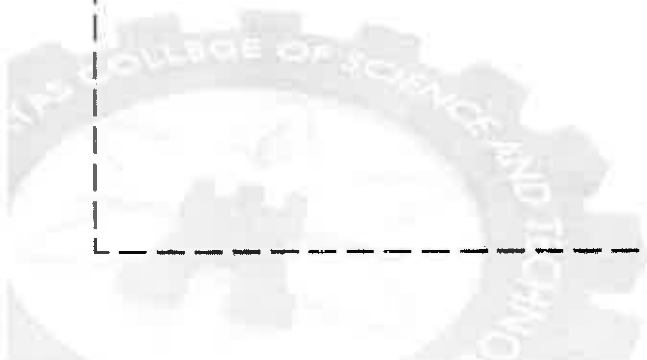
PRODUCTION

- The College generated income from various resource generation projects such as the Cafeteria, Guiang Building, Mini Hotel and Dormitories. Other sources of income of the college were from the different services offered by the different departments such as production of various kinds of furnitures, wooden trophies, plaques, give aways, souvenirs and assorted garments; repair and maintenance of private vehicles, refrigeration and air conditioning.
- The Leon Campus (LNCA) generated income from the following production and other resource generation projects: piggery; rentals of venues, equipment and facilities/dormitory; seedlings (nursery); canteen; cutflowers; vegetables; rice and corn; firewood/scrap materials/old newspapers; and fruit trees/bananas/coconut.
- The Barotac Nuevo Campus (DJSMMNC) generated its income of Php 88,227.94 from the following production and other resource generation projects: bakery, canteen, test booklets, rentals, toga rentals, internet café and BSED Mini-Mart.
- The Dumangas Campus generated its income from the following production and IGPs: Canteen, sound system and repair of electronic gadgets, CAD short term course for young professionals, pineapple and rice production, rentals of facilities and fish pond, space rental for photocopier and water dispenser.

- The Miag-ao Campus (SIPC) launched the operation of the SIPC Bakeshop last November 23, 2009. The bakery project is a nutritional project by the Italian Cooperation Agency, Embassy of Italy which provided baking equipment, utensils and initial ingredients to produce nutritious, quality and affordable bread for the poor people in the community.
- Through the SIPC, the Provincial Government approved the proposed two (2) Out-of-School Youth skills training programs under Project MYRNA for OSY of the Municipality of Tubungan and released Php 30,000.00 for each 120 hours training program which started on February 21, 2009. A total of 40 out-of-school youth were undergoing the skills training, 20 OSY for welding skills training and another 20 OSY for carpentry skills training.
- The Miag-ao Campus (SIPC) launched Adopt a School Program with San Rafael National High School as Partner School on November 19, 2009. Mayor Julieta N. Flores graced the activity during the launching and the signing of the Memorandum of Agreement.

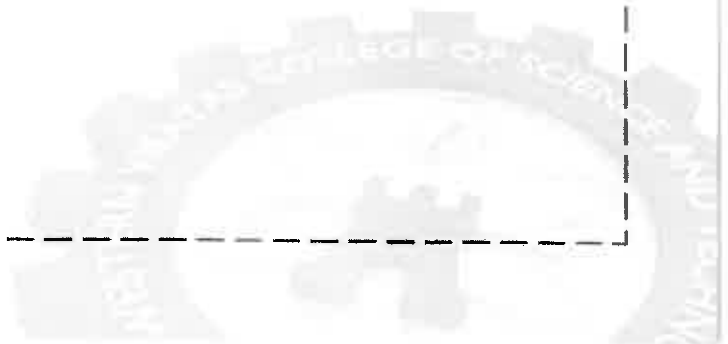
PHYSICAL FACILITIES DEVELOPMENT

- The College had started the construction of the Entrepreneurial Lane Phase I which will start to operate this January 2010.
- The College proposed the constructions of the Student Center, Planning and Production Office for Planning, and ICT-CEA Building.
- The HRT Service Center composed of a receiving lounge, fine dining restaurant and a small function room has been proposed and included in the priority project of the Planning Office with an approved building budget of P2 million.
- The Leon Campus (LNCA) together with KOICA constructed the IT Training Center, the Multi-Purpose Agriculture Laboratory Building and the 2-unit Greenhouse with Dip Irrigation System. 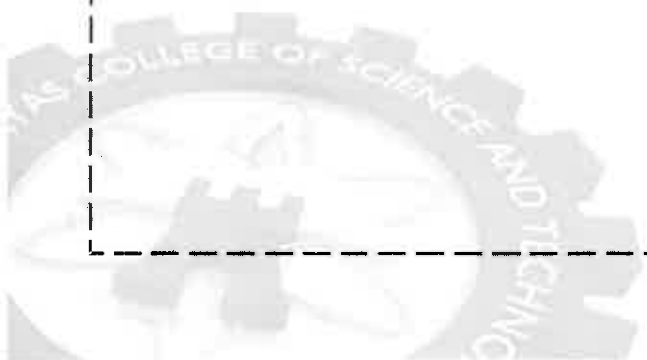

Figure 1. *Distribution of Graduates by Cluster of Discipline AY 2008-2009*

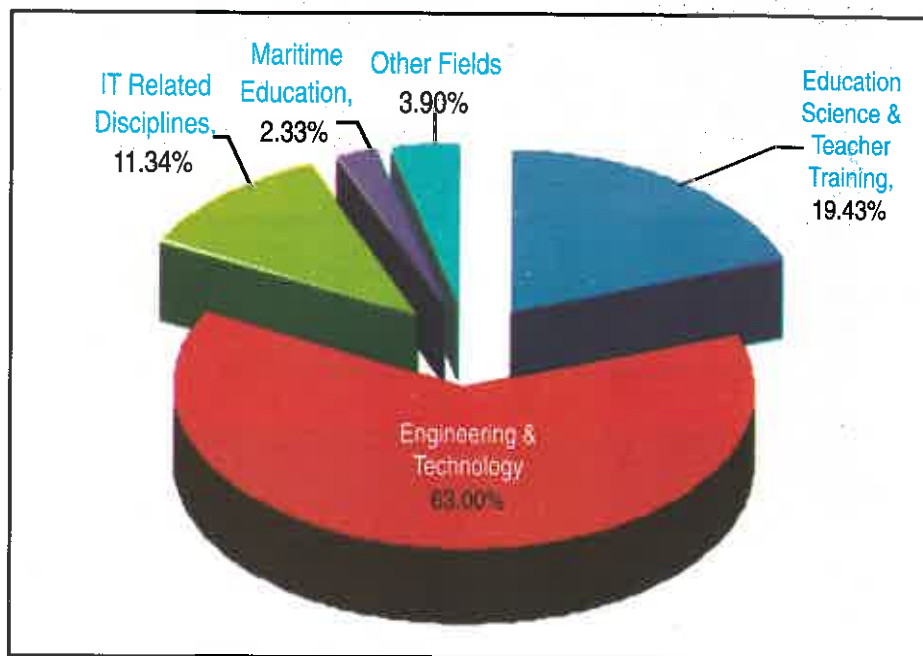
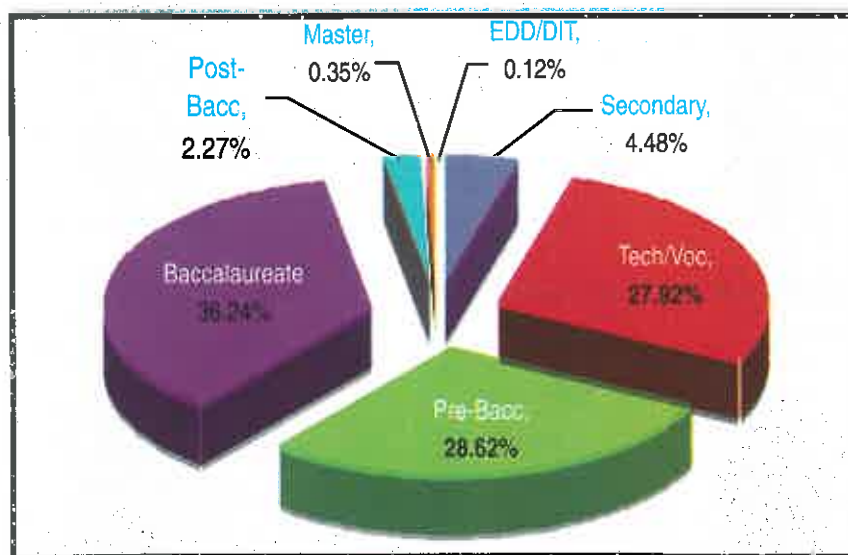

Figure 3. Distribution of Enrolment by Cluster of Discipline (First Semester) AY 2009-2010

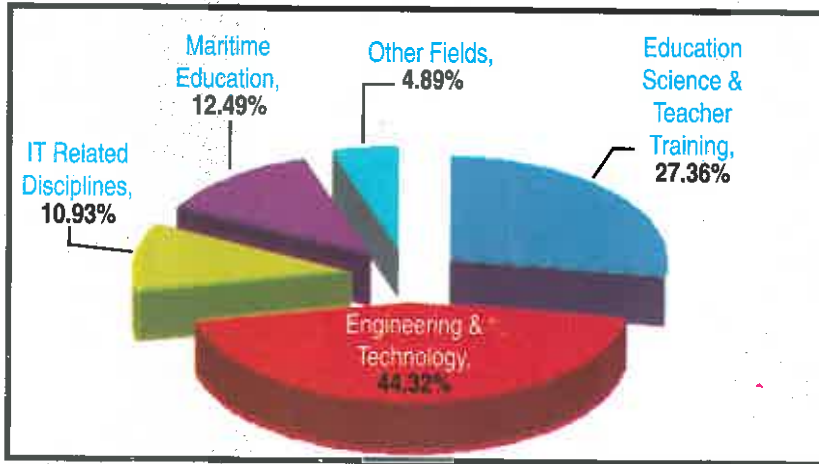
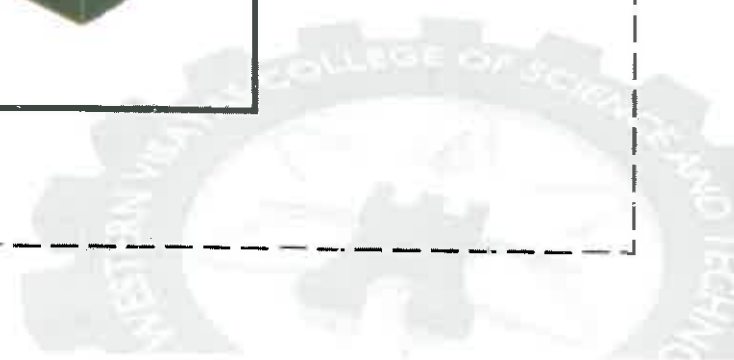
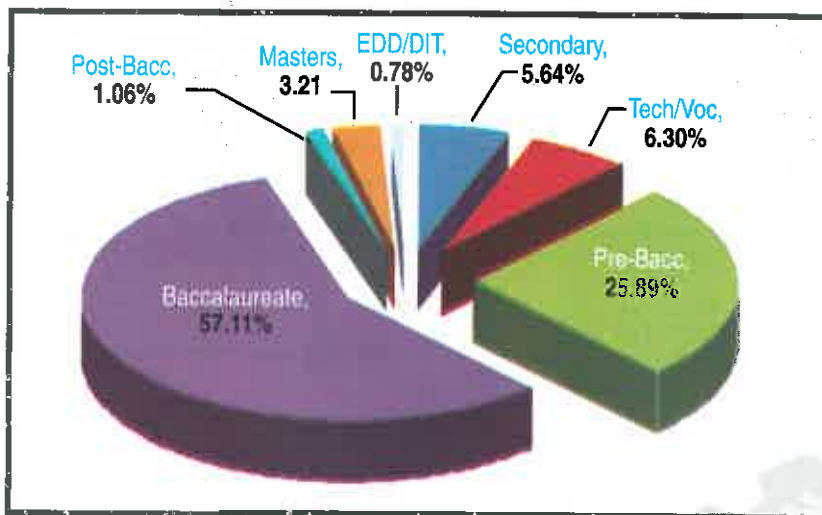

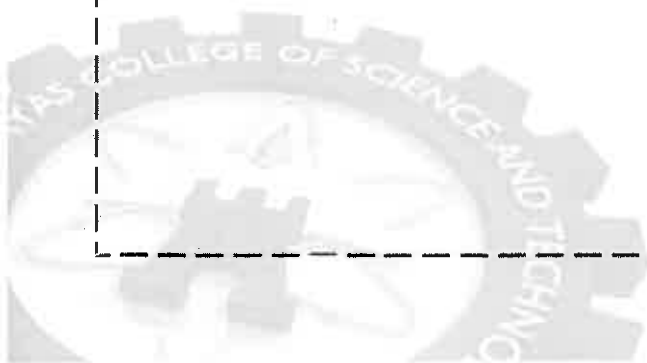
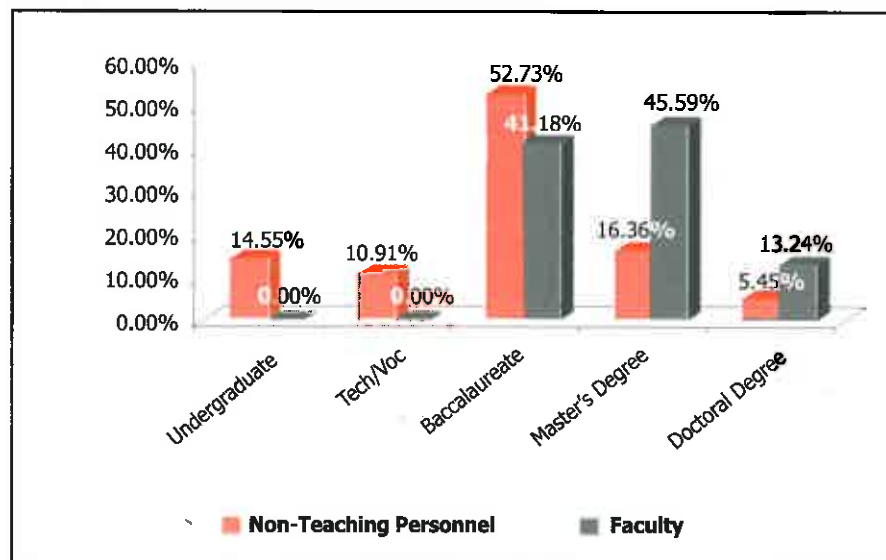


Figure 5. Distribution of Personnel as to Highest Educational Attainment CY 2009

Figure 13. *Distribution of Graduates by Cluster of Discipline AY 2008-2009*

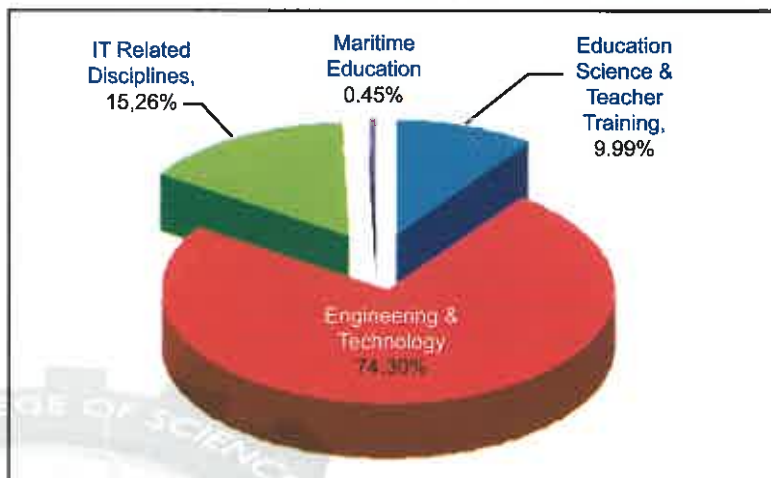
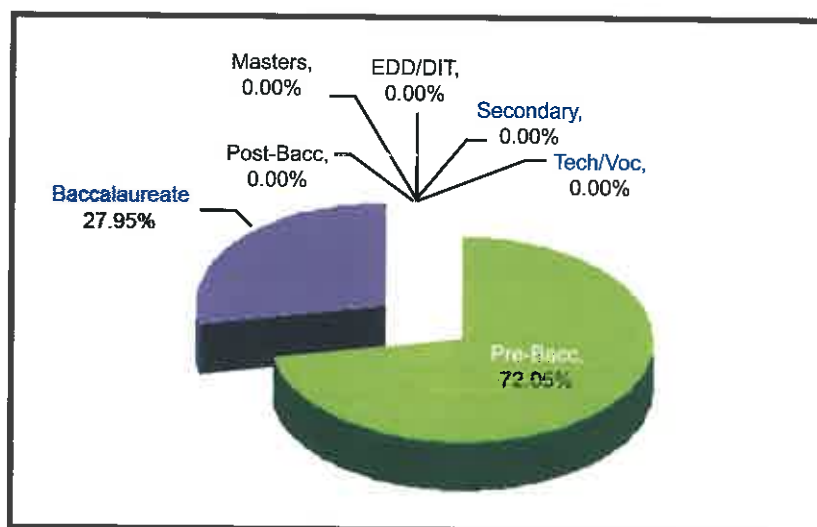

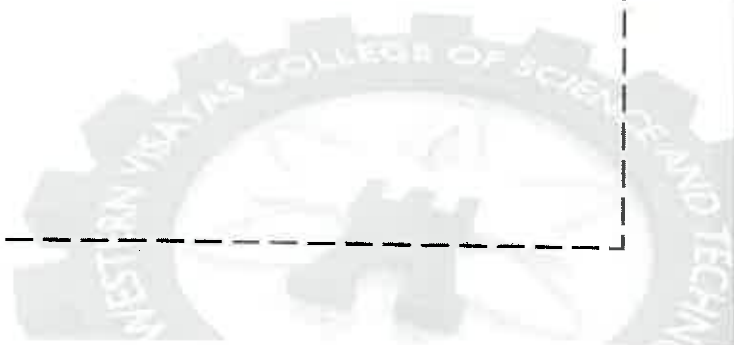


Figure 15. Distribution of Enrolment by Cluster of Discipline AY 2009-2010

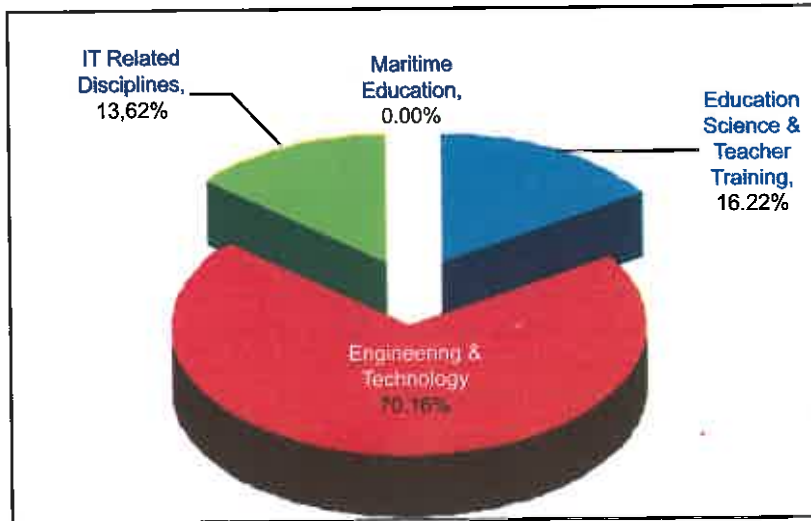
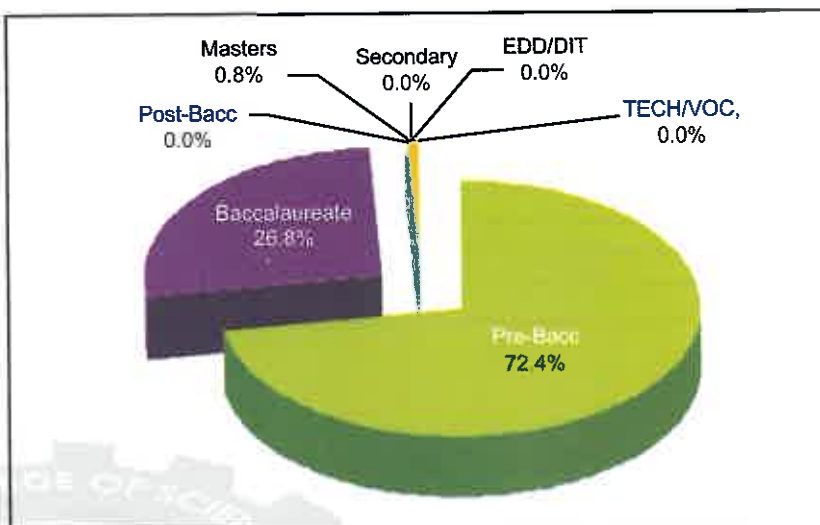

Figure 17. *Distribution of Personnel as to Their Highest Educational Attainment CY 2009*

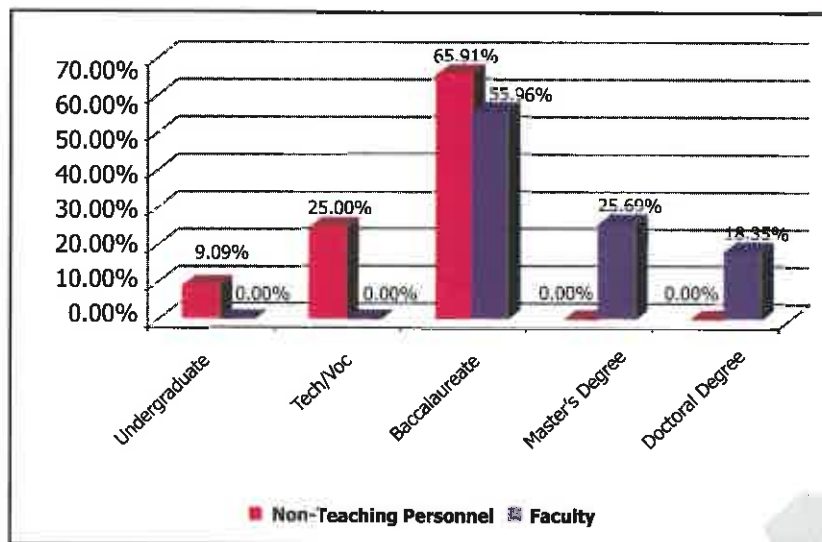

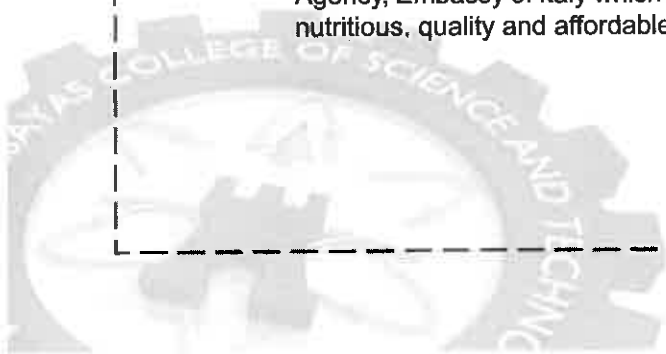

Figure 18. *Distribution of Graduates by Cluster of Discipline AY 2008-2009*

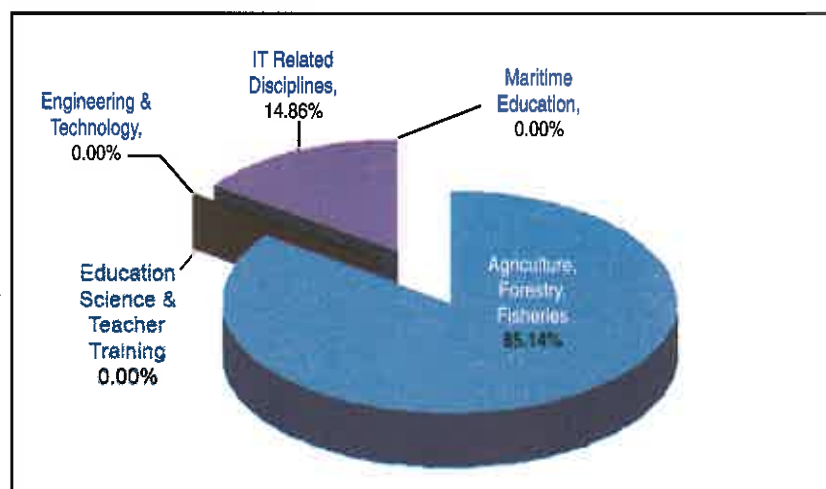
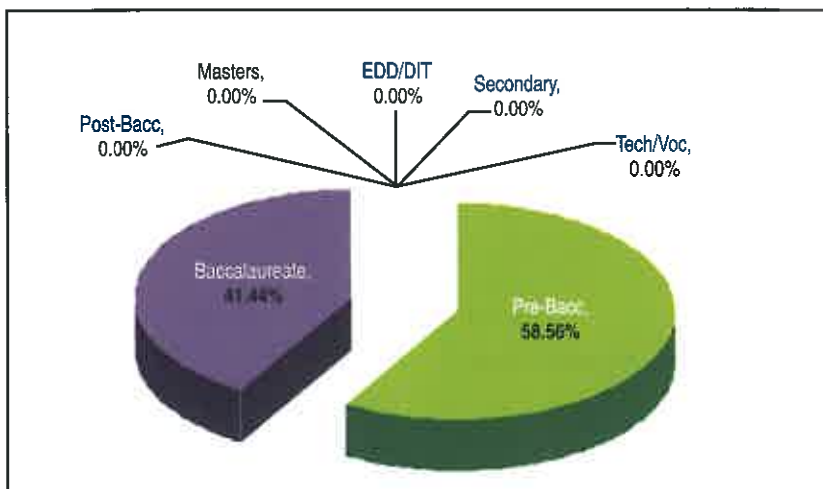

Figure 20. Distribution of Enrolment by Discipline AY 2009-2010

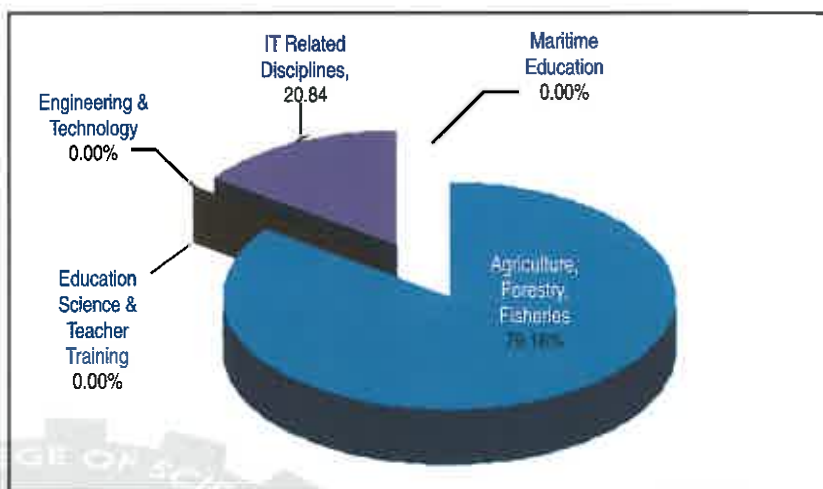
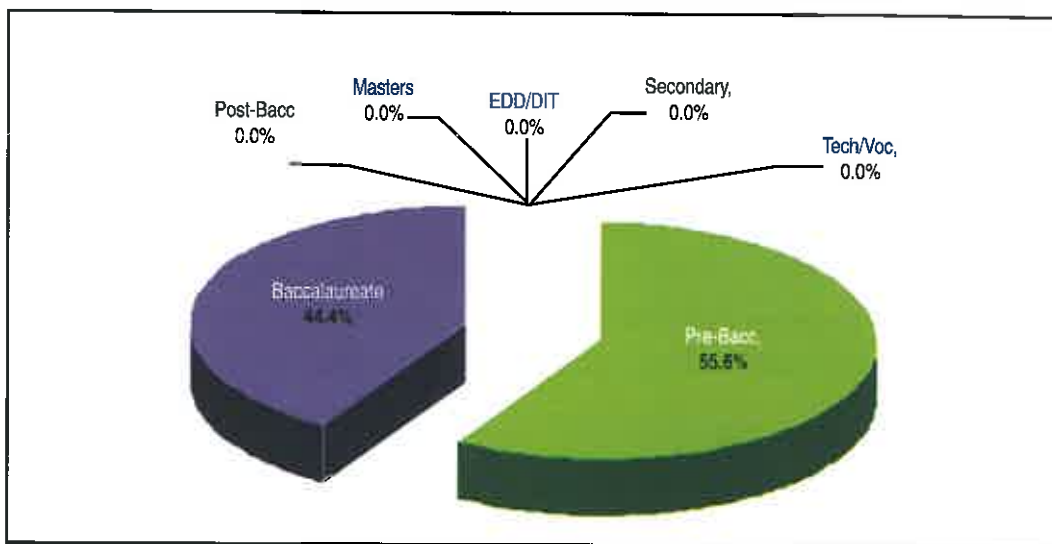

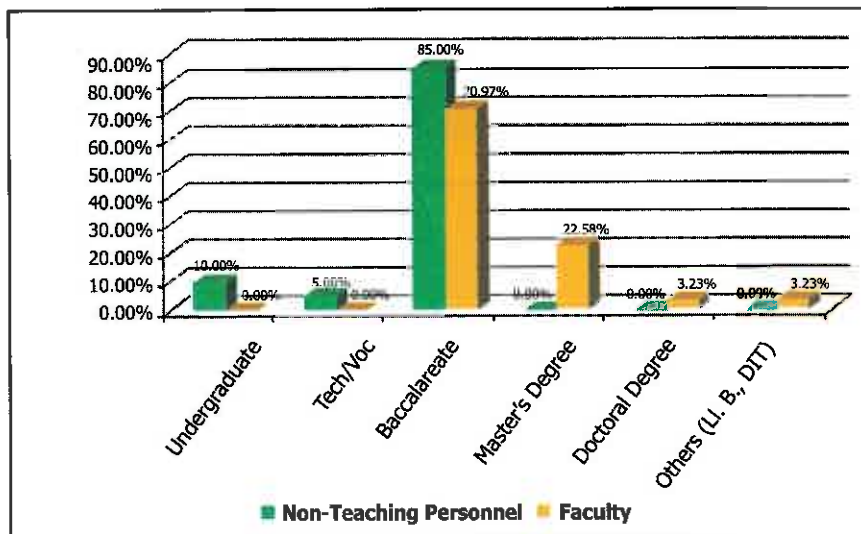

Figure 23. *Distribution of Graduates by Cluster of Discipline AY 2008-2009*

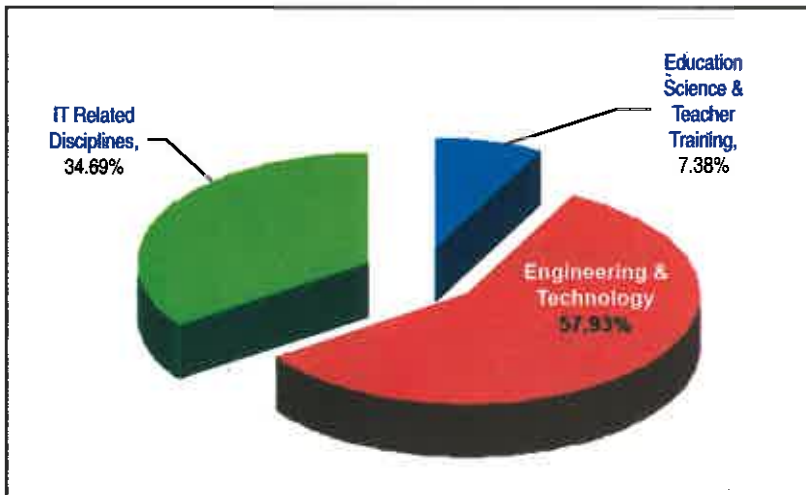
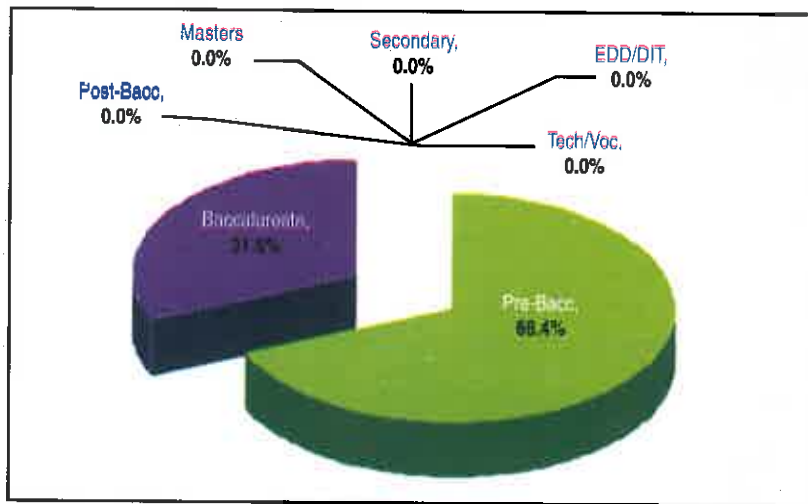

Figure 25. Distribution of Enrolment by Cluster of Discipline AY 2009-2010

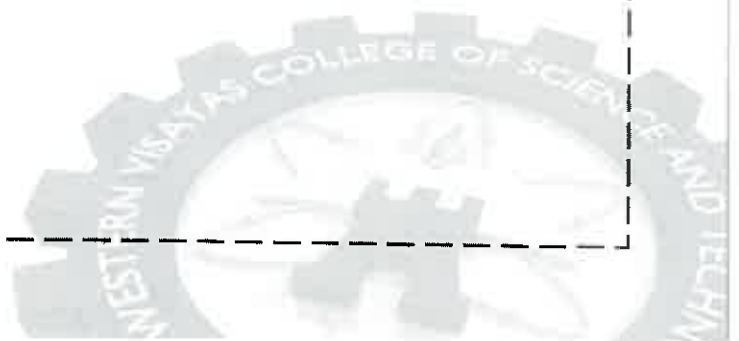
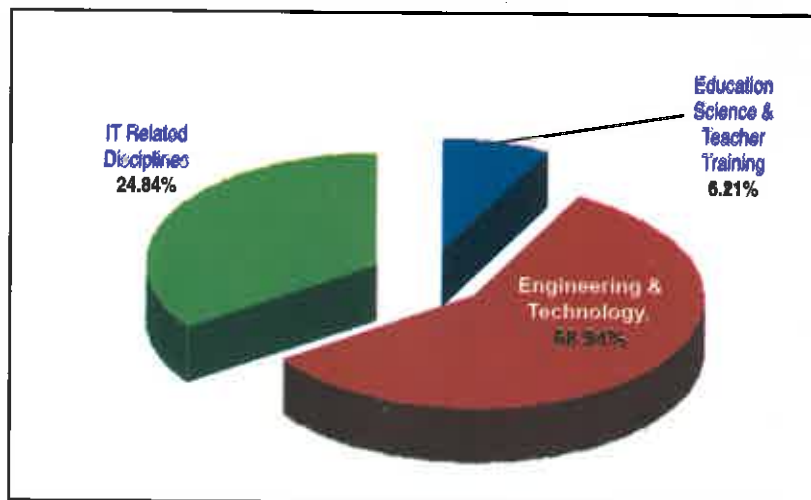
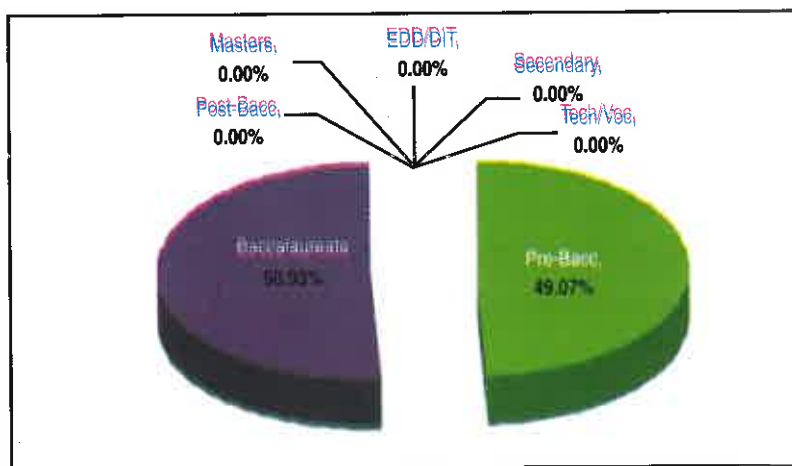

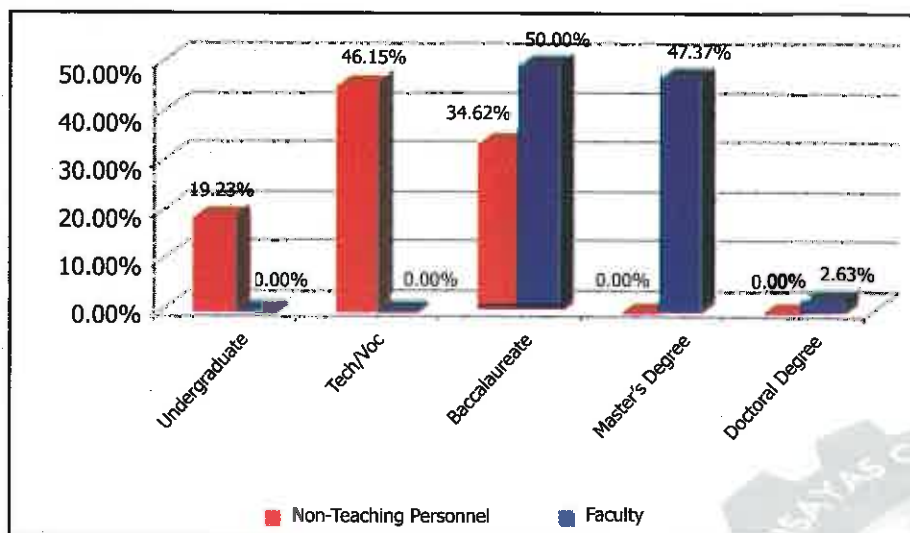

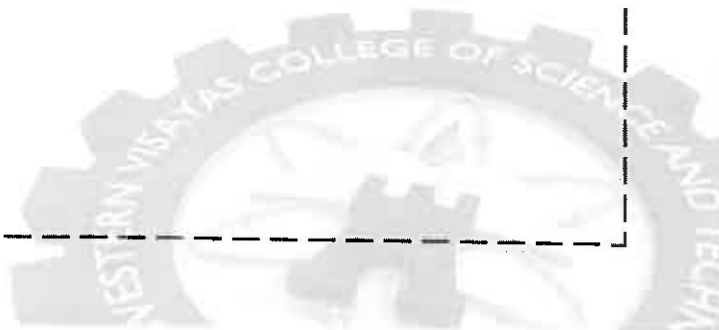

Figure 28. *Distribution of Graduates by Cluster of Discipline AY 2008-2009*

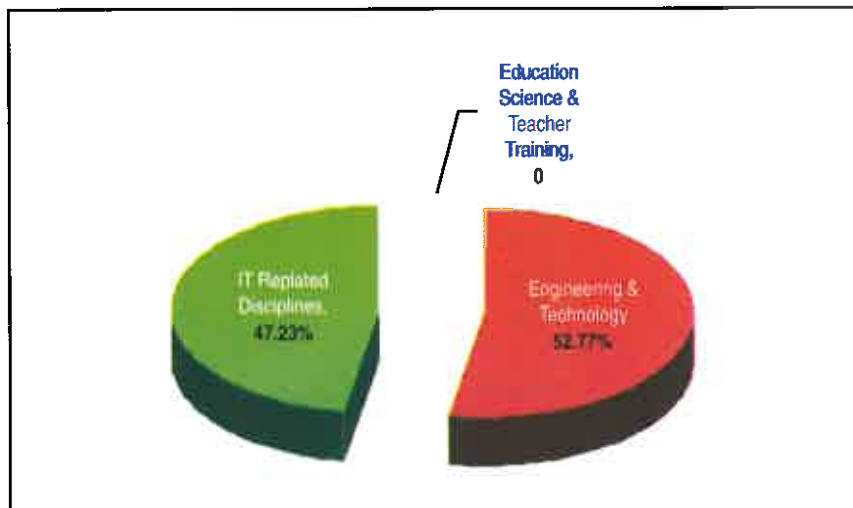
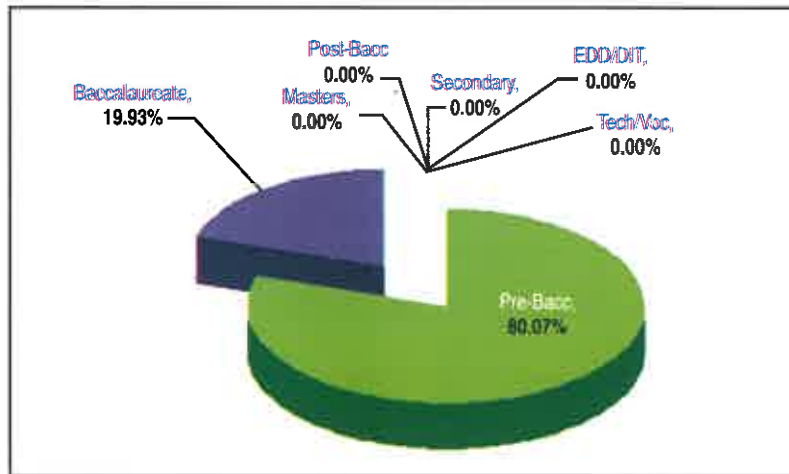

Figure 30. Distribution of Enrolment by Cluster of Discipline AY 2009-2010

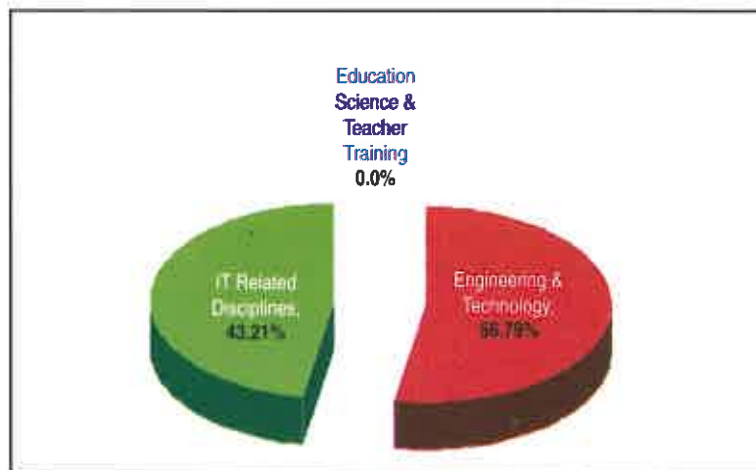
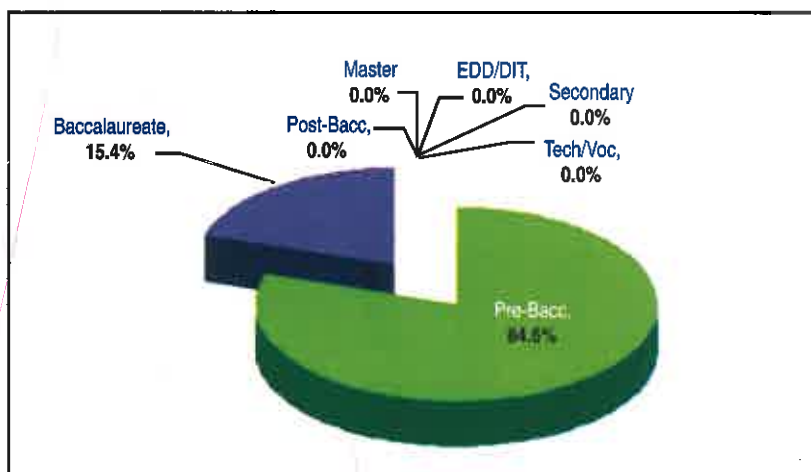

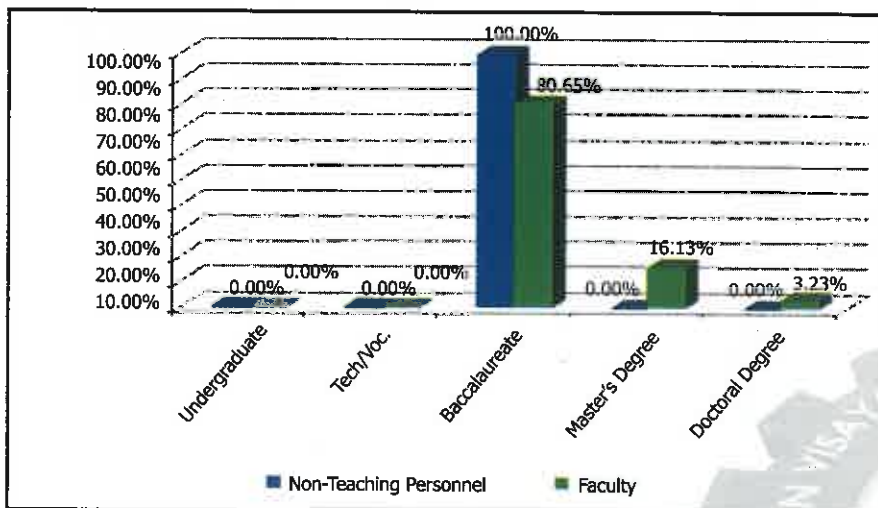

EXTENSION

The Extension Services had undertaken the tutorial classes with the trainees and young boys under the care of Don Boy's Home and Vocational Training Center. On the other hand, community services done by the faculty and students were much in demand considering their varied expertise in the field of sports, culture and the like.

The Extension Office in partnership with CWTS student volunteers, the PNRC, Rotary Club of Dumangas, PTCA and the community had accomplished various activities including the Blood Donation Campaign which made as one of the advocacies of the extension services of the College.

Other activities included the following:

1. Coastal Clean Up at Roma Beach, Dacutan, Dumangas, Iloilo which utilized 165 CWTS students and three faculty members;
2. Community Needs Assessment Survey of Brgy. P.D. Monfort South and P.D. Monfort North;
3. Collating data and interpretation of results of the assessment survey

PDMC had conducted the Electronics Technology Extension Services Livelihood Skills Training Seminar Workshop on Basic Public Address System sponsored by the Industrial Technology Society and ELX Department.

The Extension Office spearheaded the launching activity and signing of Memorandum of Understanding for "Buhayin ang Ilog Dumangas", Project: 10,000 Trees by 2010 and the Solid Waste Management Program as joint projects of the Municipality of Dumangas and PDMC Civic Welfare Training Service. Induction of officers of the PDMC Extension Student Volunteers was also conducted by the Office.

PRODUCTION

The canteen was made operational of its services for the College and the community. The Electronics Department had started its IGP through rentals of sound system and repair of electronic gadgets for which the proceeds become source to purchase additional tools and equipment of the Department.

The Architectural Drafting Technology Department had gained recognition in the offering of CAD short term course for young professionals. On the other hand, the Automotive Technology Department attended to the training in Defensive Driving and automotive repair and maintenance. The Computer Technology Department had also provided skills training and actual jobs in computer repair and troubleshooting.

The pineapple plantation project of the College is in its halfway of development. More than three hectares were already fully planted and cultivated with Queen Pineapple variety. Rice is also one of the seasonal crops that the College gain from its Aglalana farm though in minimal level.

Other IGPs that are being managed by the College are rentals of facilities, rental of fish pond, space rental for photocopier, water dispenser, etc.

PHYSICAL FACILITIES DEVELOPMENT

Even with the limited resources, the College had afforded the purchase of units of computers to upgrade the computer laboratory facilities to respond to the increasing rate of enrolment in Computer/Information Technology Department and to conform to the UTPRAS requirement of TESDA in offering the NC program. There had been repairs and restructuring of these laboratory rooms to make the environment conducive to learning.

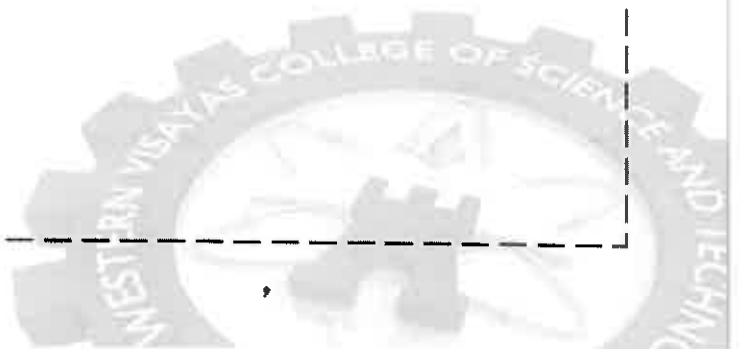
Reconstruction of ceilings and restructuring of rooms and offices were given priority in utilizing funds for repair and maintenance of building and facilities. Purchase of computer units and accessories for the computer department and offices and furnishings for the hostel was given priority using the SIDF and laboratory fees. Repainting of walls and façade of the Academic, Technology and Administration buildings were also made. Repair of rest rooms, urinals, shop rooms were also made during this year.

The release of Php 100,000.00 from the Office of the Governor was made for the construction of additional bleacher at the Multi-Purpose Hall which was made useful for all students of the College.

The transfer of title for the different lots owned by the College are presently being given top priority specifically the Aglalana Passi City lot. The titling requirements for other lots owned by the College are likewise being processed to facilitate the release of their respective titles.

COLLEGE PUBLICATION/NEWSLETTER

The College had released its issue of a newsletter, "PDMCIAN" to feature significant achievements and activities of the College especially of the Administration, faculty and staff. This was realized through the efforts of the College Publication Adviser, Mrs. Merlinda Buenviaje and staff. With enough budget, the said newsletter will be published twice a semester with faculty, staff and administration as contributors.

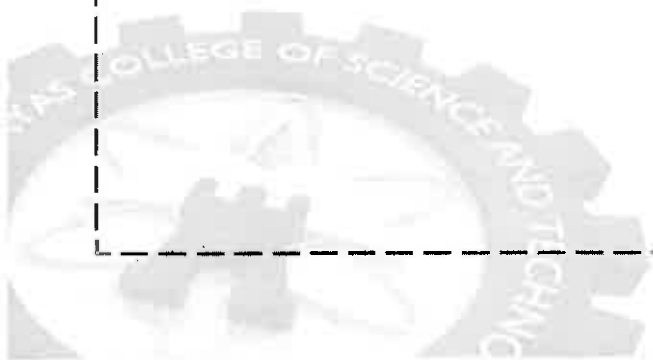

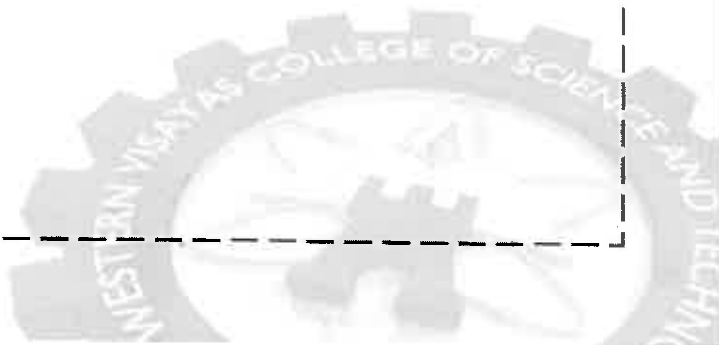

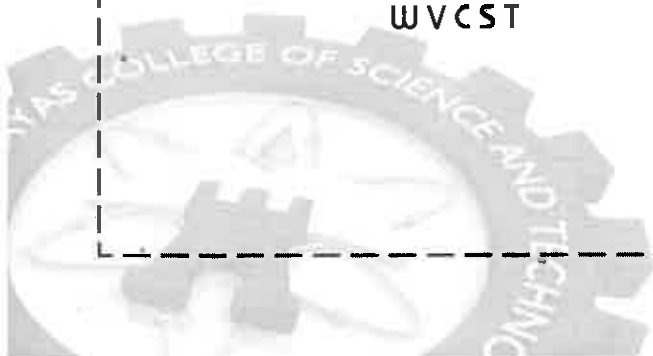
