# 2010 ANNUAL REPORT EXECUTIVE SUMMARY

The College continuously aspires for excellence in the field of Science and Technology. With this aspiration, the College President, Dr. Luis M. Sorolla, Jr., together with the Vice Presidents for Academic Affairs, Dr. Ricardo B. Abaleña and the Vice President for Administration and Finance, Mr. Edwin T. Fos spearheaded the College in achieving the following major accomplishments . These accomplishments were realized with the full cooperation of the faculty, staff, students and community leaders.

#### INSTRUCTION

#### **Graduates**

The College has produced a total of 3,077 graduates for the school year 2009-2010. When broken down as to campuses 51.28% (1,578) of the graduates were from Main Campus, 29.25% (900) were from Miag-ao Campus (SIPC), 5.0% (154) were from Dumangas Campus (PDMC), 7.34% (226) were from Leon Campus (LNCA) and 7.12% (219) were from Barotac Nuevo Campus (DJSMMNC).

The total number of graduates this year has relatively decreased by 6.5% from previous school year.

#### **Enrolment**

The College has total enrollees of 11,094 for the second semester SY 2010-2011 where 60.02% (6,659) were from the Main Campus, 23.05% (2,557) were from Miag-ao Campus, 6.25% (693) were from Leon Campus (LNCA), 5.30% (588) were from Barotac Nuevo Campus and 5.38% (597) were from Dumangas Campus (PDMC). This school year, the college enrolment relatively increased by 3,0%.

The COE main campus student grabbed the 7th place in the September 2010 Licensure Examinations for Teachers. Furthermore, the College was hailed No. 3 top performing school in the September 2010 Electrical Engineer Licensure Examination.

#### **Instructional Activities**

To facilitate learning and capability enhancement, students were sent to various trainings/seminars/OJT programs. The College also conducted various activities for students development such as industry and vesssel familiarization tours. Furthermore, the students from the Dumangas campus took summer jobs with the assistance from DOLE.

On the other hand, the COE Educator's Sub Guild conducted a symposium on various areas such as *Teaching Strategies for Mathematics*, *Global Warming*, *Updates on Technology and Livelihood Education*, etc. Also, the Barotac Nuevo campus conducted a Module Writing Seminar-Workshop for the GEPS and Technology Instructors.

The Leon campus developed the Agricultural Crops Production NC II module that is being utilized by partner organization in Nagano, Japan.

#### **Curriculum Development**

The CIT Main Campus prepared the *Institutional Competency Assessment (ICA)* for BIT major in Construction Technology and Furniture and Cabinet making Technology. Barotac Nuevo campus also prepared a modular approach course syllabus and designs a model using multimedia presentation in ICT-based instruction.

A seminar-workshop for the creation of a College Almanac to synchronize all programs, projects, and activities of the college was held last December 8 at the Library Viewing Room, Main Campus.

On the other hand, a partnership between Dumangas campus and Don Bosco Iloilo was terminated because of the implementation of the new program in Bachelor of Science in Industrial Technology major in Mechanical Technology.

#### **Accreditation and Certification**

BS Community Development program was subjected to reaccreditation for 3rd Level by the AACCUP last August 13. Furthermore, BSHRT, BS Architecture, BSEE, BSECE, and BS MarE programs had also their preliminary survey visit by the AACCUP last December 8-11. On the other hand, the BS Marine Engineering AJA ISO 9001:2008 accreditation was on the pipeline for approval.

#### RESEARCH

#### Researches

The College had 13 completed faculty researches. These researches were successfully completed through the research enthusiasm of 21 faculty researchers and 5 engineering students. Meanwhile, the College look forward for the completion of the 25 on-going faculty research studies and projects. Furthermore, the Leon campus administrator, Dr. Capaciete, continues to work on her three (3) on-going researches entitled "A Tracer Study on BS in Agriculture Graduates", "Adaptability Test of Korean Corn and Rice Varieties", and "Varietal Trials of Korean Vegetables".

#### Research Activities

The Office of the Research Services Division had developed its first semi-annual publication of newsletter for research. The office also forwarded four (4) Instructional Materials developed by the college faculty members for Copyright and ISBN registration.

During the College foundation week, the Office of Research Services Division had its first Research Fair event graced by Mayor Jed Patrick Mabilog and attended by faculty and students of different schools and colleges in Iloilo. In this event, six (6) research centers were launched namely Center for Industrial Products Development, Center for Food Products Development, Center for Robotics, Center for ICT Research, Center for Education Research, and Center for Social Science Research. Also, newly developed technologies were launched during the event such as ISUY Robot, Rat Track, and ISUY Delicacies.

The College through its Research Services Division also hosted various seminar-workshops/trainings such as Lego Robotics Workshop conducted at the CIT accreditation room last March 23-26. This activity was in collaboration with the Singapore Polytechnic and was attended by the engineering faculty of the College.

Another activity hosted by the College was the "Seminar-Workshop on Project Identification, Proposal Evaluation, Intellectual Property (IP) Orientation and Patent Drafting" last November 15-19. The seminar-workshop was organized by the WVCIERD under the Department of Science and Technology (DOST) with Dr. Carmelo V. Ambut as the Consortium Director.

Research Director Dr. Carmelo V. Ambut and Automotive faculty Jogie E. Cubar attended the 2010 National Invention Contests and Exhibits organized by the DOST-TAPI last November 25-27 at SM Cebu Trade Hall, Cebu City. Mr. Cubar was the regional finalist for Creative Research category (LIKHA) representing Western Visayas.

Other faculty and staff were also sent to various international, national, regional and local conventions/conferences/ seminars which could be an avenue for new knowledge and sharing of research practices. Some of these were Regional Research Symposium for faculty and students being organized by PASUC VI, Regional and National Conventions on Statistics, International Conference on Higher Education Research, and many others.

#### **Inventions and Innovations**

For the past two years, the College had 16 Patent and Utility Model applications for registration. Three (3) of these applications were granted Utility Model registrations by the Intellectual Property office last February 2010. Another four (4) patent applications from the group were on Phase il examination.

On December 2010, two (2) more Utility Model applications were forwarded to the Intellectual Property office for registration.

Several inventions and innovations of the faculty researchers are now in production and for sale such as the Valve Spring Remover with Seal Puller of Mr. Jogie E. Cubar, the Folding Tailor Square of Mr. Lino B. Baldevarona, and the Electronic Water Level Controller of Mr. Julius D. Catalan, Dr. Renerio S. Mucas and Dr. Antonio D. Derequito.

#### **Awards**

Several awards were bagged by the student presenters during the 1st Regional Symposium for Students organized by PASUC VI last March 12 at West Visayas State University. Rueben Articulo and his co-researchers with their research paper entitled *Push Cart* won the *Best Paper* and Jhovanny de la Cruz and company with their research paper *Universal Oil Filter Remover and Installer* won *Third Best Paper* in the Developmental Research category.

Antonette Lagradante with her paper How Effective is Agrarian Reform in Raising Farm Incomes won also 3rd Runner Up in Social Science category.

Another regional symposium on R&D highlights was organized by PASUC VI last October 29 at West Visayas State University. The symposium was participated by the faculty from different SUCs. Prof. Julius Catalan with Dr. Renerio Mucas presented their research paper entitled *Electronic Water Level Controller* and won 2nd Best Paper in the Developmental Research Category.

Another pride was brought to the College triumphantly by Mr. Jogie E. Cubar with the help and support of the Research Director Dr. Carmelo V. Ambut. Mr. Cubar's invention Valve Spring Remover with Seal Puller was hailed Champion during the 2010 Visayas Islands Invention Contests and Exhibits conducted by DOST-TAPI in Amigo Plaza Mall, Iloilo City. This triumph made Mr. Cubar's invention qualified in the National level to represent the Visayas region. The 2010 National Invention Contests and Exhibits of DOST-TAPI conducted in Cebu City brought another success and honor to Mr. Cubar and the College by winning 3rd Place.

#### Other Accomplishments

The College had generated income of Php 624,764.00 from the sale of the different Instructional Materials developed by the faculty.

The Research and Statistics Assistance Center (RSAC) of the College was able to serve 36 clients for statistical assistance and data analyses this year. Most of the clients of the center were the undergraduate students of the college who were on thesis writing. Five (5) faculty researchers conducting institutional researches were also given free assistance on data analyses. The center had generated income of Php 14,690.00.

#### 3

#### **EXTENSION**

The college extended supports to the community through its various extension programs such as Community Organization program, Education program, Socio-Economic program, Health and Nutrition program, Environmental program, and other social services. The College through its Extension Services Division had a total of 108 extension activities/projects. Some of the beneficiaries of these activities were the Out-of-School Youths, unemployed parents, fish vendors, and partner agencies beneficiaries.

The Extension Services Division of the College received several certificates of appreciation and recognition from various agencies such as the Philippine Red Cross, PASUC VI Extension Managers Council, Breaking Barriers for Children and Young Adults, Oton Central Elementary School, Department of Education, and Office of the City Mayor.

The College through its competent personnel also offered expert services such as Resource Persons/Speakers, Competency TESDA Assessors, Thesis and Dissertation advisers, Judges, Accreditors, Sports Coaches/Officials, Documenters, and Consultants.

#### **PRODUCTION**

The Main campus had generated Php 4,492,485.73 from its Income Generating Projects. The Main campus Entrepreneurial Lane - Copy Shoppe and Futtukaffe already took off early this year. Also, the CIT-BFAT fabricated school uniforms of students from the University of San Agustin. Several Instructional Materials developed by the faculty are on sale already through the WVCST Cooperative Store.

The Leon Campus continues to have their various IGPs such as the Piggery, Production from Rice, Corn, Vegetables/Fruits, and Seedlings, Rentals of Equipment, etc.

The Pineapple plantation of Dumangas campus with CHED is on its fourth hectare completion already. However, this project was proposed to have a joint venture with Artech Philippines which aims to develop the 80-hectare farm lot into a sugarcane plantation.

The Barotac Nuevo campus generated Php 116,303.87 from their income generating projects such as Bakery, Canteen, BSEd Mini-Mart, Internet Cafe, Test Booklets, Garments, Rentals, and Banana Plantation.

#### PHYSICAL FACILITIES DEVELOPMENT

The WVCST main campus had established an operational *Entrepreneurial Lane*. Students Government Center, ROTC Armory, Rainwater Catchment structure, and Concrete fencing of the New Site were some of the completed infrastructure projects/construction of the college. There was also a proposed plan for the Entrepreneurial Lane extension. Furthermore, the BSHRT Service Center plan was already completed and was prepared for public bidding.

The Dumangas campus installed door and grilled windows to preserve and protect the memorabilia exhibits of the late Cong. Narciso D. Monfort with Php 93,000.00 donation from Carmen T. G. Monfort. Also the repair of the PDMC's Technology Building is still on-going through the supervision of DPWH and Engineering Office of Dumangas with Php 250,000.00 project cost from Cong. Ferj Biron's fund.

The Leon campus of the College together with KOICA had constructed a Multipurpose Agriculture Laboratory building. They had acquired also two (2) greenhouse units with Drip Irrigation, again KOICA collaboration. Leon campus had constructed also one (1) study center.

The Miag-ao campus completed the 2nd phase of construction of the Administration Building for the offices of Accounting, Cashier, Supply, and COA Auditors.

Figure 1. Distribution of Graduates by Cluster of Discipline AY 2009-2010




Figure 3. Distribution of Enrolment by Cluster of Discipline (First Semester) AY 2010-2011




Figure 5. Distribution of Personnel as to Their Employment Status CY 2010





Figure 6. Distribution of Personnel as to Their Highest Educational Attainment CY 2010



Figure 13. Distribution of Library Attendance by Program



Figure 15. Distribution of Graduates by Cluster of Discipline AY 2009-2010




Figure 17. Distribution of Enrolment by Cluster of Discipline AY 2010-2011




Figure 19. Distribution of Personnel by Employment Status CY 2010




Figure 20. Distribution of Personnel by Highest Educational Attainment CY 2010



Figure 21. Distribution of Graduates by Cluster of Discipline AY 2009-2010



Figure 23. Distribution of Enrolment by Cluster of Discipline AY 2010-2011




Figure 25. Distribution of Faculty as to Their Employment Status CY 2010






Figure 27. Distribution of Graduates by Cluster of Discipline AY 2009-2010




Figure 29. Distribution of Enrolment by Cluster of Discipline AY 2010-2011



Figure 30. Distribution of Enrolment by Program Level AY 2010-2011



Figure 31. Distribution of Personnel by Employment Status CY 2010




Figure 32. Distribution of Personnel by Highest Educational Attainment CY 2010



Figure 33. Distribution of Graduates by Cluster of Discipline AY 2009-2010



Figure 35. Distribution of Enrolment by Cluster of Discipline AY 2010-2011





#### **WELFARE PROGRAM**

- The FEA Board conducted series of sessions and approved the proposal to broaden the coverage of the FEA welfare program. Hospitalization, Death assistance to members, Death assistance to retirees, Outpatient Medical Reimbursement and Calamity assistance. This proposal is ready for ratification by this GA.
- 2. Provident Fund- our amended CNA contained already the establishment of the institutional Provident Fund. A committee was created by the President chaired by VP Edwin Fos. We are now strategizing the implementation of this fund based on the guidelines set by EO 641 of the office of the President of the Philippines and the IRR through the DBM circular 2008-3. - 2. Deans of different colleges/Directors of various offices are now prioritizing training needs of faculty/ employees giving due considerations to priority areas of operation. Should there be no chance for others to attend seminars and conferences, proposals for professional enhancement/ lakbay aral is considered by the administration. All proposals for lakbay aral or similar intention shall be channeled to, screened and endorsed by the Staff Development Committee prior to the approval of the College President. Campus Administrators may approve the latter similar undertakings with the blessing of the College President.

### **PROFESSIONAL SYMPOSIA**

Local associations under the FEA umbrella are given the liberty to schedule their own professional lectures based on the felt need of the local organization. At least, one professional lecture is conducted per semester. On the part of the FA in the main campus, two (2) professional lectures have been conducted as to date. Gender and Development, Morals and Ethics related issues are the most favored topics for discussion.

## **WELLNESS PROGRAM**

- We failed to implement FEA driven sport related activities in the employee ranks due to some existing sports program initiated by the College connecting our campuses together. Ex. The Presidential cup- a table tennis tournament. The College spent an amount for this activity and it involves the employees representing different campuses.

We are working in tandem with GAD committee in order to focus the utilization of College funds to the common projects of GAD and the faculty/employees association.
