A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO TOY TRUCKS INCORPORATED FOR THE PROCUREMENT OF MOTOR VEHICLE FOR UNIVERSITY Project Reference No. ISAT U GOODS 2024-01-019

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF MOTOR VEHICLE FOR UNIVERSITY on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Six Million Five Hundred Thousand Pesos Only (PhP 6,500,000.00) inclusive of applicable taxes;

WHEREAS, a Pre-Procurement Conference was held on April 23, 2024 with the BAC, BAC Secretariat and end-user representatives to determine the readiness of the procurement project;

WHEREAS, a Pre-Bid Conference was held on May 14, 2024 with two (2) prospective bidders in attendance, namely;

- 1. Toy Trucks Incorporated
- 2. Nissan Commonwealth, Inc.

WHEREAS, during the scheduled date for the selling of Bid Documents on May 20-25, 2024, One (1) interested bidder availed the official bidding documents in the amount of Six Thousand Five Hundred Pesos Only (PhP 6,500.00), namely;

1. Toy Trucks Incorporated

WHEREAS, one (1) bidder submitted a bid proposal within the deadline set on May 25, 2024 at 5pm, namely;
