A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF DIGITAL KIOSK FOR VPEA
Project Reference No. ISAT U GOODS 2023-09-082

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF DIGITAL KIOSK FOR VPEA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Five Hundred Twenty Thousand Pesos Only (PhP 520,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, in the first posting the Bids and Awards Committee (BAC) declared the initial bidding as failed under BAC Resolution No. 736, dated October 18, 2023;

WHEREAS, on November 10, 2023, the Bids and Awards Committee (BAC) posted the Invitation to Bid for the Procurement of Digital Kiosk for VPEA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University in accordance with Section 21.2. of the IRR of RA9184;

WHEREAS, ON November 14, 2023, a notice of postponement for pre-bid conference was issued to all participating prospective bidders and invited observers that the projects scheduled on November 20, 2023 will be rescheduled on November 21, 2023 due to conflict of schedule of bidding;

WHEREAS, a Pre-Bid Conference was held on November 21, 2023 with two (2) prospective bidders in attendance, namely;

1. AEP Systems Integration, Inc.
2. Wyz Watch

WHEREAS, in response to the said posting, two (2) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on December 2, 2023 at 5pm, namely;

1. AEP Systems Integration, Inc.
2. Success Business Machines Corporation

WHEREAS, during the bid opening held last October 18, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;




