A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF SECURITY SERVICES FOR THE UNIVERSITY
Project Reference No. ISAT U GOODS 2023-11-092

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF SECURITY SERVICES FOR THE UNIVERSITY on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Eight Million One Hundred Nine Thousand Four Hundred Twenty Six Pesos and Sixty Four Centavos Only (PhP 8,109,426.64) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on December 11, 2023 with four (4) prospective bidders in attendance, namely;

1. Stelsen Security Agency Corporation
2. Mount Carmel Security Agency, Inc.
3. Parisan Security Services Inc.
4. Dyna Arms Security, Inc.

WHEREAS, in response to the said posting, two (2) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on December 22, 2023 at 5pm, namely;

1. Mount Carmel Security Agency, Inc.
2. Parisan Security Services Inc.

WHEREAS, during the bid opening held last December 28, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

WHEREAS, the BAC has conducted post-qualification to Mount Carmel Security Agency, Inc. last January 8, 2024 and determined that the bidder concerned has complied with and is responsive on all the requirements and conditions as specified in the Bidding Documents and as provided under Section 34.4 of 2016 Revised Implementing Rules and Regulations of RA 9184;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that MOUNT CARMEL SECURITY AGENCY, INC., as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF SECURITY SERVICES FOR THE UNIVERSITY and awarded the contract in the total amount of Seven Million Nine Hundred One Thousand One Hundred Thirty Two Pesos and Four Centavos Only (PhP 7,901,132.04) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
