A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS ICT SUPPLIES FOR UNIVERSITY-EPA
Project Reference No. ISAT U GOODS 2024-01-013

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF VARIOUS ICT SUPPLIES FOR UNIVERSITY -EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Three Million Seven Hundred Thirty One Thousand Seventy One Pesos And Fifty Centavos Only (PhP 3,731,071.50) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on November 7, 2023 with three (3) prospective bidders in attendance, namely;

1. AEP Systems Integration, Inc.
2. Handlink, Inc.
3. Microgenesis Business Systems

WHEREAS, in response to the said posting, two (2) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on November 18, 2023 at 5pm, namely;

1. Oxord Computer Solutions & Repair Center
2. Armix Copier Rental Services & Sales

WHEREAS, during the bid opening held last November 20, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that OXORD COMPUTER SOLUTIONS & REPAIR CENTER as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF VARIOUS ICT SUPPLIES FOR UNIVERSITY and awarded the contract in the total amount of Two Million Six hundred Thirty One Thousand three Hundred Thirty Seven Pesos Only (PhP 2,631,337.00) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.




