WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF BINOCULAR COMPOUND LIGHT MICROSCOPE & GEL DOCUMENTATION EQUIPMENT FOR CAS-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Two Hundred Fifty Thousand Pesos Only (PhP 250,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on November 7, 2023 with one (1) prospective bidder in attendance, namely;

WHEREAS, in response to the said posting, one (1) prospective bidder purchased the bidding documents and submitted their proposal within the deadline set on November 18, 2023 at 5pm, namely;
