## A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO JGC CONSTRUCTION FOR THE RENOVATION OF UNIVERSITY CLINIC-EPA Project Reference No. ISAT U INFRA 2025-01-002

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the RENOVATION OF UNIVERSITY MEDICAL CLINIC-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Three million Four Hundred Seventy-Two Thousand Four Hundred Eleven Pesos and Ten Centavos Only (PhP 3,472,411.10) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on December 5, 2024 with Two (2) prospective bidders in attendance, namely;

- 1. Urbancon Builders and Supply
- 2. D X'Men Builders Corp.

WHEREAS, during the scheduled date for the selling of Bid Documents on December 5-14, 2024, Two (2) interested bidders availed the official bidding documents in the amount of Five Thousand Pesos Only (PhP 5,000.00), namely;

- 1. Giantwest Construction Corporation
- 2. JGC Construction

WHEREAS, Two (2) bidders submitted a bid proposal within the deadline set on December 16, 2024 at 5pm, namely;

- Giantwest Construction Corporation
- 2. JGC Construction

WHEREAS, during the bid opening held last December 17, 2024, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

To declare that JGC CONSTRUCTION as the Single Calculated and Responsive Bid (SCRB) for the RENOVATION OF UNIVERSITY MEDICAL CLINIC- EPA and awarded the contract in the total amount Three Million Two Hundred Eighty-Eight Thousand Five hundred Eighty-Two Pesos and Forty-Eighty Centavos Only (PhP 3,288,582.48) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
