**RESOLUTION NO. 029, s. 2024**

**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROVISION OF JANITORIAL SERVICES AND MAINTENANCE PERSONNEL-EPA  
Project Reference No. ISAT U GOODS 2024-01-015**

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROVISION OF JANITORIAL SERVICES AND MAINTENANCE PERSONNEL-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Three Million Eight Hundred Thirty Two Thousand One Hundred Fifty Eight Pesos and Seventy Two Centavos Only (PhP 3,832,158.72) inclusive of applicable taxes, "short of award";

WHEREAS, on November 14, 2023, a notice of postponement for pre-bid conference was issued to all participating prospective bidders and invited observers that the projects scheduled on November 20, 2023 will be rescheduled on November 21, 2023 due to conflict of schedule of bidding;

WHEREAS, a Pre-Bid Conference was held on November 21, 2023 with three (3) prospective bidders in attendance, namely;

1. Pacific Sun Manpower Solutions
2. Tekton Entre-Worker Cooperative Iloilo
3. Royal 88 Manpower Services

WHEREAS, in response to the said posting, two (2) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on December 2, 2023 at 5pm, namely;

1. Pacific Sun Manpower Solutions
2. Tekton Entre-Worker Cooperative Iloilo

WHEREAS, during the bid opening held last December 4, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

WHEREAS, the BAC has conducted post-qualification to Tekton Entre-Workers Cooperative similar to the project last June 15, 2023 and determined that the bidder concerned has complied with and is responsive on all the requirements and conditions as specified in the Bidding Documents and as provided under Section 34.4 of 2016 Revised Implementing Rules and Regulations of RA 9184;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that TEKTON ENTRE-WORKERS COOPERATIVE as the Lowest Calculated and Responsive Bid (LCRB) for the PROVISION OF JANITORIAL SERVCIES AND MAINTENANCE PERSONNEL-EPA and awarded the contract in the total amount Three Million Sixty One Thousand Two Hundred Eleven Pesos and Fifty Two Centavos Only (PhP 3,061,211.52) without vat; and
- b. To recommend for approval of the University President the foregoing findings.
