## **RESOLUTION NO. 054, s. 2024**

## A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE REHABILITATION OF AUTOMOTIVE SHOP, OFFICE AND CLASSROOM-EPA Project Reference No. ISAT U INFRA 2024-01-01

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the REHABILITATION OF AUTOMOTIVE SHOP, OFFICE AND CLASSROOM-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Two Million Four Hundred Three Thousand Sixty Three Pesos and Seventeen Centavos Only (PhP 2,403,063.17) inclusive of applicable taxes, "short of award";

WHEREAS, in the first posting the Bids and Awards Committee (BAC) declared the bidding as failed under BAC Resolution No. 684, dated December 4, 2023;

WHEREAS, on December 7, 2023, the Bids and Awards Committee (BAC) posted the Invitation to Bid for the Rehabilitation of Automotive Shop , Office and Classroom-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University in accordance with Section 21.2. of the IRR of RA9184;

WHEREAS, a Pre-Bid Conference was held on December 15, 2023 with eight (8) prospective bidders in attendance, namely;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that GIANTWEST CONSTRUCTION CORPORATION as the Lowest Calculated and Responsive Bid (LCRB) for the REHABILITATION OF AUTOMOTIVE SHOP, OFFICE AND CLASSROOM-EPA and awarded the contract in the total amount of One Million Nine Hundred Thirty Three Thousand Two Hundred Twenty Two Pesos And Twenty Two Centavos Only (Php 1,933,262.22) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
